Cat & Dog Licenses: Unspayed females and unneutered males are \$10.00 each. Spayed females and neutered males are \$5.00 each. You must show proof of a valid rabies shot. A late fee of \$15.00 shall be assessed per dog or cat for failure to obtain a license by April 1, 2013.

**April Election:** There will be a spring election on **Tuesday**, **April 2**<sup>nd</sup> for Superintendant of Public Instructions, State Supreme Court, Court of Appeals Judge, District II, Circuit Court Judge, Branch 1, Village President, Village Trustees, and School Board. Polls will be open at the Reedsville Municipal Building, 217 Menasha St., from 7:00 am until 8:00 pm

**The Remote Readers have arrived!** One of the goals of the Village Board and Utility Dept. is to eliminate estimated water bills. To accomplish this goal in 2013, we need your assistance. Currently, MCO is installing these meters on Wednesday mornings from 8:00 am to 1:00 pm. If that day and times will work for you, please contact the Clerk-Treasurer Office at 754-4371 to schedule an appointment. They will be doing a cross connection inspection at the same time which is a Dept. of Natural Resources requirement.

**Cell Phones vs. Land Line Phones:** Many people no longer have a land line (Frontier) phone in their homes. Cell phones are used in place of regular phones. If this is the case, please call the Village-Clerk's office at 754-4371 and let us know your phone number. Even if you have a land line phone and a cell phone, it would be helpful to have both phone numbers on file in case of an emergency.

**Solid Waste and Recycling Service Reminder:** Carts must be placed at least 4' apart or on separate sides of your driveway with the arrow pointing to the street. Failure to do this may result in your carts not being emptied.

Chipping will done the 1<sup>st</sup> & 3<sup>rd</sup> Tuesday in the months of April thru October. Clean woody vegetative material no greater than six inches (6") in diameter, and not less than four feet (4') in length can be shredded. Lumber (treated and untreated), skids, and other construction and demolition waste can not be shredded. Place near curb with cut ends facing street. If you are interested in the wood chips, the pile is located near the compost area. Chipping for April will be April 2<sup>nd</sup> and 16<sup>th</sup>.

**Compost:** Yard waste such as grass clippings, leaves, and yard & garden waste shall be disposed of by composting the material or leaving it at the Village compost site. Items NOT to be put in the compost are: stumps, roots, shrubs with intact root balls, animal waste, and sod. A sign will be erected by the compost that is ready to be used by the public.

**Vehicle Nuisance:** It is illegal for any partially dismantled, non-operating, wrecked, junked, unregistered or discarded vehicles to be placed or stored on any public or private property within the Village limits for a period of longer than five (5) days, unless said vehicles are stored within an enclosed building. This ordinance does not apply to property zoned for the sale or repair of vehicles. Having a vehicle behind your garage or under a tarp does not meet the requirement of an enclosed building. **Open Book:** The Village of Reedsville Assessment Roll will be available for examination on April 18, 2013 from 4:00 pm to 6:00 pm in the hall of the Reedsville Municipal Building, 217 Menasha Street, Reedsville, WI. To schedule a time to discuss an assessment with the Village Assessor, please contact the Village Clerk/Treasurer at 920-754-4371 during normal business hours.

Deep vein thrombosis (DVT) is a blood clot in a vein deep in the body. With deep-vein thrombosis, clots can break up, travel through the bloodstream and lodge in the lungs (called a pulmonary embolism), leading to severe organ damage and even death. Up to 100,000 people in the U.S. die each year from a pulmonary embolism, according to the Centers for Disease Control and Prevention, Fortunately, most blood clots are preventable and can usually be treated if discovered early. Several factors contribute to clot formation, including:

Slow blood flow, often due to lying or sitting still for an extended period of time Pooling of blood in a vein, often due to:

- ◆ Immobility
- ♦ Medical conditions
- ◆ Damage to valves in a vein or pressure on the valves, such as during pregnancy

Injury to a blood vessel Clotting problems Catheters placed in a vein

Being older than 60, being overweight or obese, having high blood pressure or being a smoker also increases risks. Taking birth-control pills or prescription hormones for menopause symptoms may also increase your risks.

Symptoms of DVT include:

Pain

Swelling of a limb Tenderness along the vein, especially near the thigh Warmth

Redness, paleness or blueness of the skin of the impacted limb
