Friends of St. Patrick, Inc.

The Friends of St. Patrick, Inc. of Maple Grove will celebrate their 20th Anniversary on Sunday, September 9th, 2012. Visitors from around the state and country will attend to reconnect with their Irish ancestors. The historic Irish settlement of the Maple Grove township accounted for over 43% of the Irish in Manitowoc County in the 1880's, and was one of the largest Irish settlements in Wisconsin. Irish families at this time were usually large, averaging 6.3 children for each mother. More than half of the 19th century Maple Grove children came from families with 8-18 children. The St. Patrick's church was the center of the Irish Community and relied on the services of Belgium, Austrian, Czech and other non-Irish

priests for the first 43 years of its existence. Only six of the 24 priests before 1893 were Irish priests, including the 14 year pastorate of Rev. George A. Casey. An analysis of 1,100 Maple Grove Irish settlers, their parents and siblings, shows that the most common surnames of those born before 1848 when the community was founded were; Murphy, Sullivan, O'Brien, Hayes, Morrisey, O'Niel, Kelly, Meehan, Connors, Gill, Cavanaugh, Halloran, Hogan, Maloney, Rolland, Shea, Daley, Fenlon, O'Hearn, Lorrigan, and Mullins. Many of those planning on attending the celebration in September will bear the same surname as those who settled in Maple Grove over 160 years ago. St. Patrick's Church closed as an operating Catholic parish in 2003. The Friends of St. Patrick, Inc. purchased the historic church building, which is now used for wakes, non-catholic weddings, concerts, and other non-catholic services. The celebration on September 9, 2012 will begin with an outside Catholic Mass at 10:30 A.M. an Irish Stew lunch, Hamburgers, Brats, Refreshments, Sweets, Kolache making demonstration and sale, a large silent auction, kids & adult games, old car show, living cemetery tours, narrated bus tours of the area and a visit to an operating Irish dairy farm. Artist Bob Kellner will be working on the grounds. There will be Irish entertainment throughout the day, including Irish Dancers from De Pere, David Logan from New York

City, Michael Murphy, and Harpist Cheryl Murphy, of Green Bay, Bill Clancy, of Greenleaf, bagpiper Peter McGinty from Two Rivers, and The Hussey Family from Brillion. A raffle with monetary prizes of \$500, \$250, \$100, 2-\$50, 2-\$25 will be held with the drawing at 4:00 p.m. September 9th. Winners need not be present. Tickets are available from any member and will also be available on the grounds the day of the picnic. 

Important information about safely taking over-thecounter pain relievers

Acetaminophen, ibuprofen and other over-the-counter pain relievers are often recommended for people with pain. These drugs can reduce fever and relieve many kinds of mild to moderate pain (backaches, headaches, sprains, arthritis and menstrual cramps.)

Acetaminophen and ibuprofen are generally regarded as safe and effective, having relatively few side effects when properly used. But just because they are widely recommended and regarded as safe, it doesn't mean it is harmless.

Acetaminophen and ibuprofen are active (yet often undetected) ingredients in more than 100 other products - making it easy to take too much of the drug and put your health at serious risk.

Other products that may also contain these include:

- Cough syrups
- Cold and flu products
- Headache medications
- Allergy relief products
- Sinus products/decongestants

Combining any of these medicines (if they contain acetaminophen or ibuprofen) can result in an overdose.

If your health care provider recommends using acetaminophen or ibuprofen, be sure you understand exactly how many pills (and which dosage) you should be taking each day. This applies to both over-the-counter (OTC) and prescription products.

Only take pain reliever, even if they're only over-the-counter, as instructed. Check the Drug Facts label on the product and don't take it longer than 10 days without checking with your provider.

The Food and Drug Administration (FDA) has released recommendations for the use of acetaminophen, specifically limiting the dosage in "combination" products to 325 mg., to reduce the potential for overdose.

The FDA stressed that:

- Severe liver injuries, including cases of acute liver failure resulting in liver transplant and death, have been reported with the improper use of acetaminophen.
- Maximum total daily dose should be 4 grams/day in healthy patients (less in patients who have liver damage).
- Patients should be educated about the importance of reading all prescription and OTC labels to ensure they are not taking multiple acetaminophencontaining products.
- Patients are encouraged not to drink alcohol while on acetaminophencontaining medications.

Studies show that acetaminophen overdose is a leading cause of liver failure in the U.S. More than half of these cases are linked to prescription and OTC products containing acetaminophen.

In summary, here are some guidelines for the safe use of acetaminophen and ibuprofen:

- Do not substitute sustained-release acetaminophen for immediate-release, without adjusting the dosing interval.
- When taking combination medicines (such as cold medicines), read the label closely to determine if acetaminophen or ibuprofen are any of the ingredients. Avoid taking multiple medicines at once that contain these ingredients.
- People who take acetaminophen or ibuprofen and drink three or more alcoholic beverages per day (two for women) may be at higher risk for liver problems. Even if you drink less than this, there may be special considerations regarding your consumption of alcohol and acetaminophen use.

Keep in mind that recommended daily limits and how often a person should be dosed can change. By reading all medication labels carefully and following your health care providers' orders and these guidelines, you should be able to take acetaminophen safely and effectively.

Reedsville Board of Education Meeting Minutes Monday June 18, 2012 6:00 p.m.

The regular meeting of the Reedsville School Board of Education was called to order at $6:02~\mathrm{p.m.}$ by Board President John Ebert.

1. Opening:

- A. Roll Call. John Ebert, Todd Cavanaugh, Andrew Maertz, Cory Kiekhaefer and Jeff Deprez.
- B. Additions/ Approval of Agenda. Jeff Deprez requested item F., approval of 1.67% increase for teaching staff, be removed from the consent agenda.
- C. Recognition of Senior Essay Award. Dennis Raabe spoke about the history of the Senior Essay Award and the award amount. Meg Heafy read her essay honoring teacher Mr. Aalsma; Jazmin Solberg and Colton Shamburek honored teacher/coach Bubolz and Victoria Wendt's essay honoring teacher Ms. Weise was read by Superintendent Raabe and the award was accepted by her mother.
- D. The Pledge of Allegiance was led by the award winners.

ll. Public Input:

Nancy Eichhorst spoke in opposition to the teacher and support staff handbooks especially the post-retirement benefits. Mary Klimesh spoke about the mill rate being too high and the fact that her assessment has also increased which compounds the problem. Rob Knuth spoke about the handbook, the need to lower the mill rate. He stated that if the rate doesn't go down, he will be moving when his kids graduate. Jerry Korinek asked for a list of the number of students participating in each of the Reedsville sports programs for the past school year. Harry Strother spoke about the Reedsville mill rate at \$13+ with a State average around \$9 and the need for school board members including the two recently elected members, to step up and do what they were elected to do. He also reminded the board that the enrollment was declining which will lead to additional loss of State aid. Dennis Raabe responded to the concerns.

Ill. Reports:

- A. District Administrator, Dennis Raabe spoke about the need to increase the fund balance. Even though the referendum was partially intended to solve that issue, until this year it has not been accomplished. A report will be available sometime around the end of June and it will report on the increase in the fund balance. Dennis handed out a very preliminary budget that details areas of potential cuts and increases. The report showed an overall reduction of \$233,145 is possible for the upcoming year. Dennis has fielded some calls from parents who are encouraging the school not to discontinue the Student Assurance Services insurance. He also spoke about the fact that last year the school needed to borrow \$900,000 in May and this year \$600,000 had to be borrowed to meet payroll and other immediate expenses.
- B. HS Principal Tony Butturini told everyone that driver's education has begun. He thanked the board for their participation in graduation. Tony congratulated the baseball team on winning the regional championship. Congratulations were also extended to Meg Heafy and Ben Brunner. He also thanked the summer cleaning crew on the great job that they were doing with the High School.
- C. EL/MS Principal Pat Popp reported on the RTI(response to intervention) program designed to give special attention to kids who need help in becoming proficient in reading and mathematics. June 19 the principal from Stevens Point will be at Reedsville to work with staff on developing the Positive Behavior Intervention System. The teachers will be volunteering their time to come in. Pictures of the school garden were available for anyone to look at. Special thanks were extended to Mrs. Nate and Mrs. Geiger and all of the students who participated.
- D. Supervisor of Special Education Tracie Wurm gave the statistics for the Children with Disabilities Program. There are currently

- 112 students in the program, 107 for school year 2012-13. She highlighted the placement rate of 85%. Tracie also reported on some changes with WKCE testing. The school district received a check for \$15,000 for School Based Services. Year-end reports are being finalized. Tracie also gave a report on the RTI and PBIS implementation.
- E. Maintenance Supervisor Myron Genrich introduced Gary Jahnke from Energy Control and Design Inc. Gary said the chiller that air conditions the elementary and middle school is running at about one half of capacity. A substantial amount of money has already been spent on the unit and he recommends replacement. That cost will be about \$130,000-\$135,000. The board asked Myron to research if grants and programs are available to school districts to help lower the cost of replacing the unit.
- F. Board Members- No report

V. Consensus Agenda Items.

- A. Approval of the minutes from the May 21, 2012 meeting.
- B. Approval of adding one new account for the Activity Accounts-Fitness Center. Note the purpose of this new account is fund raising activity.
- C. Employment Recommendations-Resignations-Katrina Mraz as special Ed aid, Mike Bubolz as cross country coach and Jason Ihlenfeldt as science teacher. Recommend Kyle Korinek as science teacher.
- D. Approval of IEQ management plan for the Reedsville School District.
- E. Credit approval requests for Pam Hammel and Denise DeMeyer
- G. Discussion/Action –Payment of Bills. Jeff asked what the payments labeled transportation parents were for. These were required payment for students who attend out of district schools.

Andrew Maertz made a motion to approve the Consensus Agenda Items. Todd Cavanaugh seconded and the motion carried.

F. Approval of 1.67% increase for teaching staff. The committee that presented the offer was made up of John Ebert, Andrew Maertz and Dennis Raabe. Jeff Deprez stated that his objection to the raise was that the District could not afford to give raises. Andrew Maertz made a motion to approve the 1.67% raise for the teachers. Cory Kiekhaefer seconded and the motion carried on a roll call vote with Ebert, Cavanaugh, Kiekhaefer and Maertz voting yes. Deprez voted no.

Vl. New Business

- A. Approval of switching to a higher deductible for property insurance. The District could save \$3,202 per year by increasing the insurance deductible from \$2,500 to 10,000. The last claim the District had was in 2008. Jeff Deprez moved to approve the higher deductible insurance policy. Andrew Maertz seconded and the motion carried.
- B. Recommendation for approval of compensation package for support staff. Dennis Raabe requested the same percentage increase for the support staff as was approved for the teachers. The 1.67% increase would result in pay increases ranging from 15 to 29 cents per hour. In addition Dennis requested a \$2 increase for a supervisory employee who is working at a rate well below others performing the same job. Jeff Deprez asked if the timing of the pay increases could be delayed so that the final budget figures were available. Dennis Raabe said that the board could delay them if they wanted. John Ebert made a motion to approve the support staff pay increases recommended by Superintendent Raabe. Andrew Maertz seconded. A roll call vote was taken with Ebert, Maertz and Kiekhaefer voting yes. Cavanaugh and Deprez voted no. The motion passed on a 3-2 vote.
- VII. Adjourn into Closed Session. Todd Cavanaugh made a motion for the board to adjourn to closed session at 8:05 p.m. John Ebert seconded and the motion carried.
- VII. Todd Cavanaugh made a motion to return to open session at 8:18 p.m. Andrew Maertz seconded and the motion carried.
- VIII. Todd Cavanaugh made a motion to adjourn the meeting at 8:20 p.m.

Proceedings of the Reedsville Village Board

June 18, 2012

A meeting of the Reedsville Village Board was called to order on June 18, 2012 at 6:30 PM by Village President Ritalyn Schuh. Present were: Andy Bubolz, Bob Campana, Mary Olson, Marybeth Rabideau, Jerry Reis, and Jack Siebert. Also present were: Craig Schuh, and Nanci Geiser.

The minutes of the previous meeting of June 4, 2012 were approved as presented.

A motion was made by Olson and seconded by Siebert to pay the accounts payable in the amount of \$83,491.96. Motion carried 6-0.

President Report: None **Committee Reports:**

Park & Recreation: Correspondence was presented from Amanda Schrubbe regarding having the meeting minutes included in the Reedsville News. A motion was made by Reis and seconded by Campana to approve this request. Motion carried 6-0. Installation of lights in the park was postponed until more costs can be obtained.

Public Works: A request for lights to be installed in the alley on the 500 block between Menasha and Mill Street was presented. The request was postponed until costs and a safety evaluation can be obtained. Correspondence was presented from the Manitowoc County GIS Dept regarding the U.S. Census Bureau boundary and annexation survey request. A motion was made by Olson and seconded by Rabideau to have the County do any future updates for the Village. Motion carried 6-0.

General Government: Following a discussion with Geiser, it was decided to have Board members send their personal e-mail address to Geiser and she will assist them on forwarding the village emails to that address. Geiser and Krahn will also work together to get commonly used forms on the website. Olson will review the website for items that may need to be updated. A motion was made by Olson and seconded by Bubolz to approve the three (3) year Audit Contract with Hawkins, Ash, Baptie and Co. The street closure request from Fox & Hounds was postponed until times could be obtained.

A motion was made by Bubolz and seconded by Siebert to approve the Class A Liquor License Application from Country Vision Coop-Town Mart. Motion carried 6-0.

A motion was made by Olson and seconded by Reis to approve the Class B Liquor License Applications from Reedsville Athletic Assn., Fox & Hounds, Five Alarm, Strikers, and The Old Bar. Motion carried 6-0.

A motion was made by Siebert and seconded by Bubolz to approve the Temporary Class B Liquor License Application from the Reedsville Fire Fighters. Motion carried 6-0.

A motion was made by Reis and seconded by Bubolz to approve the Soda License Applications from Fox & Hounds, Valu-Pro Power Center, Reedsville Athletic Assn., Country Vision Coop., Five Alarm, Strikers, Jim's Service & Car Wash., Colleen Café, Equity Coop., and The Old Bar. Motion carried 6-0.

A motion was made by Olson and seconded by Reis to approve the Tobacco License Application from Country Vision Coop-Town Mart. Motion carried
