

Nutrition Programs
The Nutrition Program is available to <u>ALL</u> seniors 60 years of age or older and their spouses, regardless of age. The goals of the Program promote a healthy lifestyle through good nutrition and assist in expanding social opportunities. The Nutrition Program is funded with Older Americans Act (OAA) funds, State and County funds, private contributions and participant donations. Participant donations are requested toward the cost of the meal provided. All are encouraged to contribute an amount they can afford.

Senior Dining Sites

Meals are provided in a congregate setting available at dining site locations in Kewaunee & Manitowoc Counties. Each dining site reflects the flavor of the community in which it is located. In addition to getting a delicious meal, each site provides opportunities to meet new people, renew old friendships, and keep current on programs and issues relating to seniors. Various activities are planned for participants to enjoy. Reservations are requested 24 hours in advance as meals are catered into the site on the dining site day. Contact the ADRC for information on how to reserve a meal at the dining site you wish to attend. Senior Dining Site participants contribute a donation toward the cost of the meal on the day of attendance at the dining site. Anyone non-eligible is required to pay the full cost of the meal.

Home Delivered Meals are provided to individuals who are unable to attend the dining sites and who meet home-bound eligibility requirements. Home Delivered Meal participants receive a monthly statement that states the number of meals served in a month and the cost of the meal. Participants are asked to mail back their donations.
