Notes from the Village Hall

Payment of Property Taxes: Real estate and personal property tax payments can be made in person at the Reedsville Municipal Building during normal business hours. Payments may also be made by sending a check to the following: Reedsville Municipal Building, Tax Collection, 217 Menasha St., Reedsville, WI 54230-8597. A receipt will only be sent back if you have included a self-addressed stamped envelope. All first installment taxes are due by January 31, 2011. The Village appreciates all taxes be paid by check or money order made payable to the Village of Reedsville.

Cat & Dog Licenses: Unspayed females and unneutered males are \$10.00 each. Spayed females and neutered males are \$5.00 each. You must show proof of a valid rabies shot. Please make out a separate check for the licenses as it goes into a different account.

Garbage Collection during the holidays will be Friday, December 24th and December 31, 2010.

Recycling Pick-Up: December 10th & 24th

Appliance Pick-up: In the event an appliance needs to be picked-up, residents are required to contact Larry's Hauling to schedule the pick-up. Their phone number is 682-1919

Nomination Papers for Village President and Trustees can be picked up at the Clerk/Treasurer's office during normal business hours. The completed forms need to be returned on or before January 4, 2011.

Clerk/Treasurer's office will be closed Dec. 20th thru Dec. 24th, December 31st, and at noon on December 30th.

Winter Parking Restrictions: No person shall park any vehicle on any street or alley in the Village between two-thirty (2:30) AM to six (6) AM of any day from November 1 to April 1, unless permission to do so is received from the Police Department. YOU MUST OBTAIN PERMISSION EACH YEAR, so if you had permission for last winter (2009/2010), you must obtain permission for this winter (2010/2011).

Even with permission, vehicles may not be parked on any street or alley when we receive snow. Lack of vehicles on streets and alleys allow the Village employees to clean up in a more timely fashion. If you have question on this, please contact the Reedsville Police Dept at 754-4656.

Yes, Even In Reedsville

Recently I have received calls from people in the Reedsville area, who have received calls from a company who says that they can help you with your credit card debit. The problem that I have is that my business number 920-754-4021 is showing up on their caller ID. I am writing this to say that I do not run that type of business; I have become a victim of "caller ID spoofing".

Here is what the FCC has to say about "caller ID spoofing": "Caller Identification or "Caller ID" allows you to identify a caller before you answer your telephone. It is an optional telephone service, available from your local telephone service provider for an additional monthly fee. A caller's number and/or name are displayed either on your phone (if your phone has this feature) or on an external display unit that you can buy separately. The number and/or name will appear on the display unit or on your phone after the first ring. This service also lets you identify yourself to the person you are calling.

Caller ID service, however, is susceptible to fraud. Using a practice known as "caller ID spoofing," disreputable parties can deliberately falsify the telephone number relayed as the Caller ID number to disguise the identity and originator of the call. Congress is currently considering new laws that would make this practice a crime and permit law enforcement authorities to take action against spoofers".

I am sorry for any inconvenience that this has caused to anyone in the area. The phone company has said there is nothing that I can do about this to protect myself, or to stop this from happening.

Sunrise Horse Farm

We have started a monthly newsletter called *Horse Happenings* which is being emailed to whoever would like to receive it. Just email us at sunrise_horsefarm@yahoo.com to be included.

Many people have asked how we started our program and what we are about, so here is the basic information. Sunrise Horse Farm began after a group of women read the books, *Hope Rising* and *A Bridge Called Hope*, by Kim Meeder, the owner of Crystal Peaks Youth Ranch in Bend, Oregon.

Two of the women attended an informational clinic at the ranch in June 2007. The clinic covered several topics including: basic natural horsemanship, horse management, child and horse safety, volunteer programming, fundraising, and how to obtain and maintain a 501(c) (3).

Sunrise Horse Farm was incorporated on August 22, 2007.

For the horses who call this place home, we offer a safe haven, a gentle hand, and a life purpose. These extraordinary horses, which each have their own stories of triumph and hope are paired with one volunteer and one child for a 30-90 minute session. The sessions are flexible, allowing that time to best serve the unique needs of the children/teens. All of this is done free of charge. It is our hope that through hands-on experience these children and teens will learn the values of life, family, faith, and trust.

We are in need of volunteers to help in various aspects of the program, such as being a mentor to the participants, feeding the horses, build stalls, or general daily upkeep. We here at Sunrise wish you a very Merry Christmas.

Is it your thyroid or something else?

Countless women may have undiagnosed thyroid disease (hypothyroidism) and dismiss their symptoms as simply a sign of menopause or just a normal part of "getting older." By age 50, approximately 10% of women have signs that their thyroid isn't making enough hormones. By age 60, that number jumps to about 17% of the female population.

The thyroid is a small but important gland located just under the Adam's apple in the neck. It is part of a complex system that regulates every cell, tissue and organ in the body.

Diagnosing thyroid disease involves a simple blood test called a TSH (thyroid stimulating hormone) test. Ask your health care provider if this test is indicated, especially if you have a family member with thyroid disease or if you experience excessive:

- fatigue
- cold intolerance
- forgetfulness
- hair loss
- changes in skin or nails
- muscle cramps
- feelings of depression
- constipation

Although thyroid conditions may not be preventable, most can be easily diagnosed and effectively treated with medications or less commonly with surgery. There is no cure for hypothyroidism and most patients will have it for life. If left untreated, thyroid disease can cause serious problems such as high cholesterol and heart disease. It can also affect how the body breaks down or responds to medicine.

**DIABETES TYPE III
COULD IT BE THE CAUSE OF ALZHEIMER'S?**

Nature's Sunshine has an Education Week twice a year and this was one of the webinars. More than 5 million Americans currently suffer from Alzheimer's, although, only 5-15% are considered genetic. We spend \$6 billion a year fighting cancer, but only \$500 million for Alzheimer's. (Mayo Clinic Alzheimer's Research Center). What is Alzheimer's? It is thought to be a buildup of protein-based plaques in the brain and is not a normal part of aging. There is growing evidence that the brain is "insulin resistant". Toxic proteins called ADDL (free radical) damage insulin receptor sites on brain cell membranes. First discovered a decade ago, scientists are finding accumulations of insulin in the brain of Alzheimer patients. (Dr. Klein NW Univ., Brown Univ., 9/2007)

The composition of our cell membranes is critical, made up of healthy lipids (fats). Healthy lipids: "Correction of lipid dysfunction, along with proper dietary fats, can stabilize and dramatically reverse symptoms of this illness (Alzheimer's) even if long standing". (John S. Foster MD). Any neurotoxic illness (Alzheimer's) is the result of dysfunctional cell membrane. If the cell membrane can no longer absorb insulin due to damage, the cell starves or dies. Our brain is 60% lipid (fat) and 80% of all synapses are lipid in content. NSP has several suggestions to keep our brain healthy.
