Notes from the Village Hall

Nomination Papers: Fill-in forms for Village Board Trustee can be found on the Reedsville Website under Links, on the Government Accountability Board Website under Forms or blank forms are available in the lobby in the Reedsville Municipal Building. All completed forms must be returned to the Village Clerk/Treasurer's office by 3:00 PM on or before January 7, 2014 in order for the candidates name to be placed on the ballot. All elected officials serve a two year term beginning the third Tuesday of April.

Payment of Property Taxes: Real estate and personal property tax payments can be made in person at the Reedsville Municipal Building during normal business hours. Payments may also be made by sending a check to the following: Reedsville Municipal Building, Tax Collection, 217 Menasha St., Reedsville, WI 54230-8597. A receipt will only be sent back if you have included a self-addressed stamped envelop. All first installment taxes are due by January 31, 2014. All taxes must be paid by check or money order and made payable to the Village of Reedsville.

Cat & Dog Licenses: Unspayed females and unneutered males are \$10.00 each. Spayed females and neutered males are \$5.00 each. You must show proof of a valid rabies shot. Please make out a separate check for the licenses as it goes into a different account.

Clerk/Treasurer's Office Hours: Monday thru Thursday, 8:00 AM to 3:00 PM and Friday 8:00 am to 1:00 pm. **The office will be closed all day December 23rd thru December 27th and January 1st and at noon on December 31st for the holidays.**

Is your asthma worse in the winter?

Why do asthma patients have more flare-ups in the winter? It's because they spend more time inside and it's very cold outside.

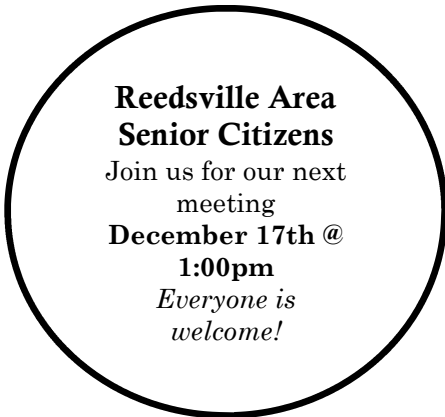
While indoors, people breathe in asthma triggers such as mold, pet dander or dust mites. When they venture outside, an asthma attack may occur after inhaling cold air.

Here are tips to avoid winter asthma attacks:

- ◆ Learn your triggers.
- ◆ Talk to your health care provider about tests to find out what your triggers are.
- ◆ Once your triggers are identified, take steps or make changes to avoid them.
- ◆ Limit exposure to pets if you are allergic. Having a dog or cat in your home may trigger your asthma.
- ◆ If dust mites are a trigger, cover bedding with mite-proof covers on the mattress, box springs, and pillows.
- ◆ Keep your house cool and dry. Dust mites, as well as mold, don't grow very well when it's cool and dry.
- ◆ Colds and flu occur more often in the winter and can lead to asthma flare-ups. Wash your hands often and stay away from people who are ill.
- ◆ When going outside, cover your face with a scarf or winter mask to avoid breathing in extremely cold air.
- ◆ Exercise indoors instead of outside during the colder months.

Make sure you have current prescriptions for all your medications. Talk to your provider about an asthma action plan. The plan should spell out when to take each type of medication and when to call your provider or seek emergency medical help.

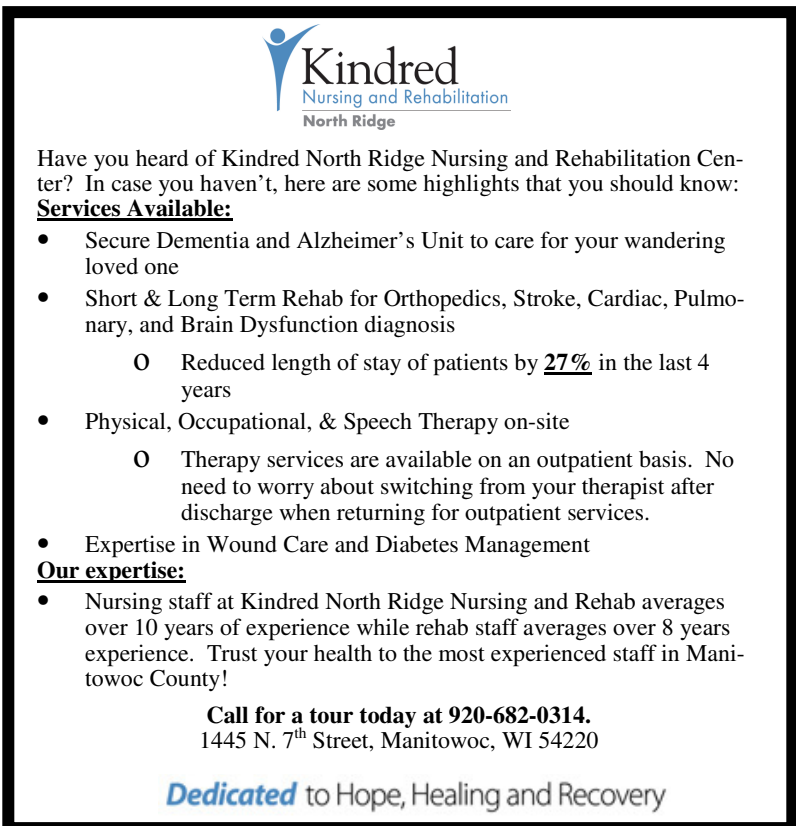

Vitamin B12 is another member of the water-soluble B vitamin complex and is used in new cell synthesis, helps maintain nerve cells, nerve sheath, helps break down fats and proteins, and with folate, makes red blood cells.
