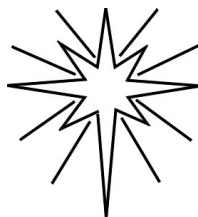

Nomination Papers: Fill-in forms for Village President or Village Trustee can be found on the Reedsville Website under Links, on the Government Accountability Board Website under Forms or blank forms are available in the lobby in the Reedsville Municipal Building. All completed forms must be returned to the Village Clerk/Treasurer's office by 3:00 PM on or before January 3, 2017 in order for the candidates name to be placed on the ballot. All elected officials serve a two year term beginning the third Tuesday of April.

Payment of Property Taxes:

- Real estate and personal property tax payments can be made in person at the Reedsville Municipal Building during normal business hours.
- Payments may also be made by sending a check to the following: Reedsville Municipal Building, Tax Collection, 217 Menasha St., Reedsville, WI 54230-8597. Taxes paid by check or money order must be made payable to the Village of Reedsville. **Cash will not be accepted.** A receipt will only be sent back if you have included a self-addressed stamped envelope.
- You can pay your taxes on-line at <https://client.pointandpay.net/web/VillageofReedsvilleWIWeb>. This address can also be found on the Reedsville Website under Links.

All first installment taxes are due by January 31, 2017.

Solid Waste & Recycling Carts need to be out on the curb by 5:00 am for service. DO NOT place carts within 4'ft of any objects such as utility poles, mailboxes, or vehicle. Carts need to be on separate sides of your driveway or at least 4' apart. Carts placed on the street or on snow banks will be not be serviced.

Cat & Dog Licenses: Unspayed females and unneutered males are \$10.00 each. Spayed females and neutered males are \$5.00 each. You must show proof of a valid rabies shot. Please make out a separate check for the licenses as it goes into a different account.

Clerk/Treasurer's Office Hours: Monday thru Thursday, 8:00 AM to 3:00 PM and Friday 8:00 am to Noon. **The Clerk-Treasurer's office will be closed December 19th thru December 26th.**

The Reedsville Municipal Building will be closed all day December 23rd, 26th and January 2nd, and at noon on December 30th for the holidays.

AFRAID OF FAT? FACE THE FACTS

We all like fatty foods - they taste good. But, for the longest time, we've been taught to avoid them. Most likely, that's because the word "fat" makes us think of our own visceral fat. Or maybe it's because most of us consume the wrong kind of fats.

These can be found in fatty fish (salmon), flax seed, and walnuts.

These healthy fats are essential because they are critical for the body to function properly. They are needed for growth and development, metabolism function, skin health, brain function, cell membrane integrity and more.

TRANS FATS: UNMASKING THE REAL CULPRIT

Trans fats are the opposite of fatty acids. These dangerous "bad" fats can attract free radicals and oxidize the LDL particles in your bloodstream. Oxidized LDL cholesterol then begins the formation of arterial plaque, resulting in the narrowing of blood flow and a decrease of oxygen to the heart, potentially affecting its function. While most of us tend to look at the overall fat content on labels, trans fats are where we really need to put our focus. Sadly, many food manufacturers can say their products have zero trans fats even if they do include it in processing. So, make sure you look for the words "partially hydrogenated" or "hydrogenated" when you read the ingredients section. If these terms are present, the product contains trans fats.

Requirements for all safety education courses

All Wisconsin recreational safety students are required to obtain a Wisconsin DNR Customer ID Number when registering for a safety education class and must provide that number to their instructor.

You can obtain a DNR Customer ID Number:

- by using our online web site to obtain your DNR customer ID number
- by calling DNR customer service from 7 a.m. to 10 p.m. at 1-888-936-7463
- by visiting a DNR service center during their regular scheduled hours.

Snowmobile course requirements

Any person who is born on or after Jan. 1, 1985 and who has reached the age of 12, must have completed and received a snowmobile safety certificate in order to operate a snowmobile in Wisconsin. The certificate must be carried while operating the snowmobile and displayed to a law enforcement officer upon demand.

This does not apply to the operation of snowmobiles upon lands owned or leased by the operator's parent or guardian. Leased lands do not include lands leased by an organization of which said operator or the operator's parent or guardian is a member.

No person under the age of 12 may operate a snowmobile unless the person is accompanied either by a parent or guardian or by a person over 18 years of age. Accompanied means to be on the same snowmobile as the operator.

Other states and provinces that issue a snowmobile safety certificate to snowmobilers will be honored in Wisconsin.

Course information

The snowmobile safety course consists of six hours of basic instruction in the principles of snowmobile safety. The course is comprised of six hours of classroom study and an optional two hours of hands-on snowmobile operation or optional snowmobile ride simulation.

Length of course

This course requires a minimum of eight hours but may be longer depending on the instructor and the student's learning ability.

Class availability

Courses vary depending on the area of the state and time of the year. There is at least one class per county per year. Click the enroll button above to search for a recreational safety education course.

Internet courses

Operators of snowmobiles have an online method to receive snowmobile safety certification. The Internet courses are available at Snowmobile Ed and Snowmobilecourse.com. Students MUST be 18 years of age or older in order to become certified by these online courses.

The proposed project also includes a stream realignment of Mud Creek to reduce existing scour issues at the bridge abutment.

The meeting is scheduled for Wednesday, December 14, 2016, at 3:00 p.m., at the Manitowoc County Highway Department, 3500 WI-310, Manitowoc, WI, 54220. Representatives from the Manitowoc County Highway Department and AECOM will be present to explain the proposed project, answer questions, and receive input on the project.

Construction could occur as early as 2018.

The monthly meeting of the Reedsville Village Board was called to order on September 8, 2016 at 6:30 PM by Village President Andy Bubolz. The minutes of the previous meeting of August 18, 2016 were approved as presented.

A motion was made by Reis and seconded by Lorrigan to pay the accounts payable in the amount of \$33,847.90. Motion carried 4-0.

Correspondence was presented From Terry Hansen & Vicky Koepen, Valders Ambulance and Ayres Associates.

At 6:45 pm, a motion was made by Reis and seconded by Siebert to convene into closed session, pursuant to WI Statute Section 19.85(1) (c) to conduct business which requires a closed session to consider performance evaluation data of any public employee over which the governmental body has jurisdiction or exercises responsibility. Motion carried 4-0. At 6:57 pm a motion was made by Reis and seconded by Walt to reconvene into open session. Motion carried 4-0.

The First Responders written monthly report was presented by Hills.

The Police Dept. verbal monthly report was presented by Mignon. The update on the placement of temporary signs was postponed until more information can be obtained.

The Utility Departments monthly written report was presented by Ponto. A motion was made by Lorrigan and seconded by Reis to have MPU send the letters to the Utilities that have antennas on the Water Tower. Motion carried 4-0

The Fire Dept. monthly report was presented by Busse. Busse presented the bills that need to be paid in the amount of \$2,406.59. A motion was made by Lorrigan and seconded by Reis to pay the bills.
