Notes from the Village Hall

Village Board meeting night has changed: Effective January 1, 2013, the regular scheduled Village Board meeting night has been changed. The meetings are held on the first and third **Thursday** of the month. The starting time will remain the same at 6:30 pm.

February Spring Primary Election

There will be a Spring Primary Election on Tuesday, February 19, 2013 for State Supreme Court and Circuit Court Judge Branch 1. Polls will be open at the Reedsville Municipal Building, 217 Menasha St. from 7:00 am until 8:00 pm.

Voter Registration Information

The federal Help America Vote Act of 2002 (HAVA) and Wisconsin State Statutes require all voters in Wisconsin to be registered in order to vote after January 1, 2006. You can register to vote up until the Friday before the election or on Election Day. You must reside at your address for 28 consecutive days to be eligible to vote and proof of residence is required.

Second opinions offer reassurance to all

When patients face a serious medical diagnosis or an upcoming surgery they often wonder if they should seek a second opinion.

Most health care providers will encourage patients to seek out another consultation, especially if the disease is difficult to diagnose, there are inconclusive test results, there are multiple treatment approaches or when the recommended option could have permanent consequences.

For patients facing surgery, the American College of Surgeons states that obtaining a second opinion before surgery is part of good medical practice and competent physicians shouldn't be offended when patients decide to seek further advice and consult with another surgeon.

When a second surgical opinion confirms initial findings, it gives patients reassurance, which can reduce anxiety and uncertainty. From a cost-savings perspective. a second opinion can save health care dollars by confirming the certainty of a need for the proposed surgery.

However, a second opinion is not necessarily "better" than a first opinion. Whether there is agreement or disagreement, the final decision is up to the patient.

Patients should remember that it is their right to seek a second opinion before committing to surgery or any treatment plan. A competent health care provider should not be offended. He or she will likely consider the patient to be an informed, proactive heath care consumer who is taking responsibility for his or her own health care.

Sunrise Horse Farm is part of the Manitowoc County Transition Advisory Committee which meets at least quarterly to address the transition needs of students with disabilities from the six school districts in the county. A new employment initiative for people with disabilities called Jobs First! has been brought forth for Manitowoc County. And this past fall Comcast did a video of some of the area students as they were doing various chores here at Sunrise Horse Farm. The video also includes other businesses and organizations from within the county. In May a group which includes area students will travel to Washington, D.C. to present the video showing how Manitowoc County is working to increase employment opportunities for youth with disabilities.

Other exciting things happening in the county include Step 'n Stones which is a self-employment option in Lincoln High School's Next Step UW program. Special education students use profits from handcrafted and personalized tie knot blankets, keychains and bookmarks to buy Chamber Bucks for worker rewards and business reinvestment. 

Manitowoc County Recycling Center

The Manitowoc County Recycling Center is now accepting food and beverage cartons for recycling! These familiar cartons are used to contain a variety of products commonly found on your grocery lists. Some examples are containers for wine, milk, soy milk, juice, cream, soup, broth, and egg substitutes. Cartons are made from paper fibers, plastic and aluminum so they are highly recyclable. When bringing your cartons to the Manitowoc

County Recycling Center they can be placed in with the plastic bottles. We anticipate that incoming plastic loads from local haulers and municipalities will have a mixture of plastic bottles and these cartons. Guidelines for Carton Recycling are similar to the current guidelines for recycling plastic bottles. Cartons should be emptied and flattened. There is no need to rinse them though.
