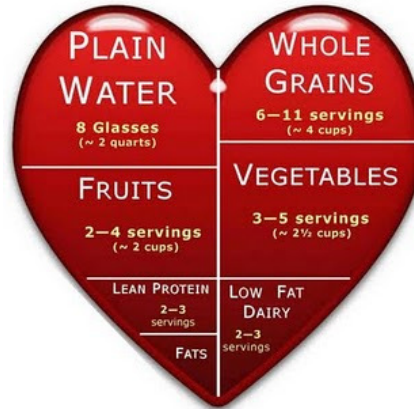

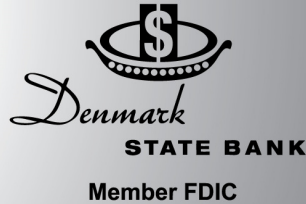

### Women and Heart Disease

February is designated "heart month." Did you know that heart disease in women is often misdiagnosed or diagnosed late in the disease process? It's true. Although progress is being made, heart disease in women is still often misdiagnosed or diagnosed later than for their male counterparts.

Each year approximately 2.5 million women nationwide are treated for cardiac problems. Most women are shocked to learn they are twice as likely to die from heart disease than from all cancers combined.

Medical professionals realize that heart disease may present different symptoms in women than in men. Warning signs for women include:

- Uncomfortable pressure, fullness, squeezing or pain in the center of the chest lasting more than a few minutes
- Jaw pain radiating down to the neck and arm
- Paleness
- Indigestion/upper abdominal pain
- Shortness of breath with mild exertion
- Chronic fatigue without reason
- Racing or irregular heartbeat
- Heart palpitations - very strong or fast
- Unexplained perspiration or cold sweat
- Lightheadedness, fainting, dizziness
- Nausea
- Upper back pain without apparent cause

If you should experience any of the above symptoms, please seek medical attention fast.

Some risk factors for heart disease can't be controlled, such as increasing age, family health history, race and gender. There are, however, many steps that women can take to protect their heart health, under the supervision of their health care provider.

My advice to women: Please don't underestimate your risk for heart disease!

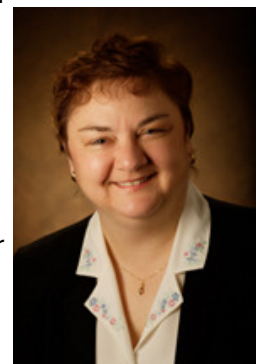
