

Thanks for supporting Lions programs.





# From the Village Hall

Each owner or occupant of any building, dwelling house, store, shop, tenement or structure of any kind and description fronting or abutting on any street, sidewalk, gutter, alley or public ground shall clean the same by sweeping, scraping or shoveling from the sidewalk by or before twelve o'clock (12:00) noon of each day, and shall cooperate with the street commissioner in keeping the streets, alleys, gutters and public grounds in a clean, tidy and orderly manner.

#### SUSPICIOUS SITUATION

A Reedsville resident reported an individual placing paperwork on their home door. The paperwork was requesting the home owner complete the paperwork containing personal information. The resident did not feel comfortable with this and reported the incident to law enforcement. The individual placing the paper returned a few days later and the Reedsville Police department was able to speak with and identify the individual. The individual was a member of the US census bureau working in our area. The worker had proper identification and the police department verified through the Chicago Regional Office this individual was conducting business in our Village. Upon speaking with the individual we learned the bureau is currently working on the American Community Survey and advised if a resident is selected but does not return the paperwork the bureau may send a representative to the address selected to follow up. We are happy the resident took proper steps to protect their personal information and property and contacted law enforcement so we could follow up on the situation. Always use caution if someone contacts you regarding personal information, ask for identification and be cautious of allowing people into your home, if you feel uncomfortable you may choose to not answer the door and contact the police department or you may ask the person to return at a later time and have someone you trust with you when the person returns. If someone contacts you stating they are from the Census bureau here are steps you may take to identify the worker. How to Identify a Census Field Representative

If you are visited by someone from the United States Census Bureau, here are some RECOGNITION TIPS to assure the validity of the field representative;

 Must present an ID Badge which contains: photograph of field representative, Department of Commerce watermark, and expiration date.

• Will provide you with supervisor contact information and/or the regional office phone number for verification, if asked.

Will provide you with a letter from the director of the Census Bureau on U.S. Census Bureau letterhead.

• May be carrying a laptop and/or bag with a Census Bureau logo.
