Notes from the Village Hall

Payment of Property Taxes: Real Estate and personal property tax payments can be made in person at the Reedsville Municipal Building during normal business hours. Payments may also be made by sending a check to the following: Reedsville Municipal Building, Tax Collection, 217 Menasha St., Reedsville, WI 54230-8597. A receipt will be sent back only if you have included a self-addressed stamped envelope. All first installment taxes are due by January 31, 2014. The Village appreciates all taxes be paid by check or money order made payable to the Village of Reedsville.

Cat & Dog Licenses are due on or before April 1, 2014. The application form is available on the website under *Forms and Permits*. Unspayed females and unneutered males are \$10.00 each. Spayed females and neutered males are \$5.00 each. Pets must have valid rabies vaccinations. Licenses can be obtained at the Clerk-Treasurer office located at 217 Menasha Street during normal business hours or by mail if a self addressed stamped envelope is enclosed with the application and fee.

If your pet has died, been sold or given away during the year you must fill out an *Affidavit of Death or Disposal* form which can be obtained on the website or in the Clerk-Treasurer's office. Please do not include the license fee with your tax payment as it goes into a different account.

Clerk/Treasurer's Office Hours: Monday thru Thursday, 8:00 AM to 3:00 PM and Friday 8:00 am to 1:00 pm. The office will be closed all day December 23rd thru December 27th and January 1st and at noon on December 31st for the holidays.

Snow & Ice Removal: The owner or occupant of any lot abutting on a public sidewalk shall clear their sidewalk of snow within twenty-four (24) hours after a snowfall and keep the same free of ice. If such snow or ice is not removed as required herein, the Street Dept. shall cause the same to be done and the cost thereof assessed against the property owner.

Utility Bill Payment Services:

You can use your credit/debit card, Amazon Payments or PayPal account to pay your utility bill. The Village of Reedsville has partnered with *Wisconsin Payments* for this service. All payments using this service are done on a PCI compliant network and no information is ever stored on any server. They are located at www.wisconsinpayments.com. You will need your utility account number each time you make a payment. **OR** You can have your utility payment deducted automatically from your checking or savings account. The application form is available on the website under *Forms and Permits*, in the Reedsville Municipal Building lobby or the Denmark State Bank – Reedsville office.

Building Permits: A building permit is required for any structural or major changes in excess of \$300.00 to your home or property. Permits cost \$20.00 for the first \$2,000 of material and labor costs and \$2.00 for each additional \$1,000 of costs after that. Building Permits are good for 6 months. The application form is available on the website under *Forms and Permits* or in the Reedsville Municipal Building lobby. Permits can be obtained at the Clerk-Treasurer office located at 217 Menasha Street.

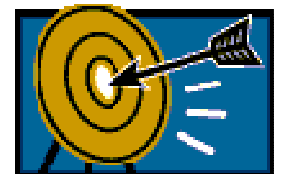

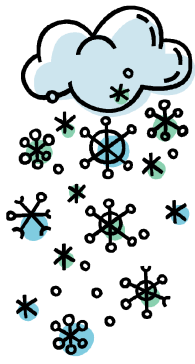

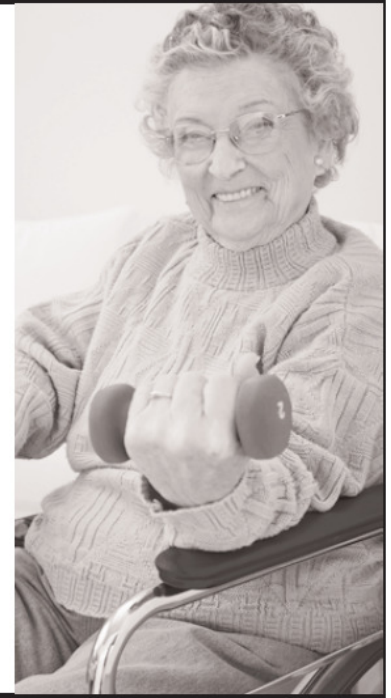

RECYCLING REMINDERS FROM DEYO DISPOSAL, INC.

Please place your green recycling cart to the curb by 6:00am.

Single Stream Recycling: ***Carts should be placed at least 4' apart on separate sides of your driveway.***

The following are items **acceptable** for single stream recycling and should be put in your green recycle cart:

Glass: Rinsed bottles and jars of any color.

Steel/Aluminum: Rinsed aluminum, steel, bi-metal cans, and non-pesticide aerosol cans.

Plastic: Rinsed containers where the neck of the bottle is smaller than the base or widest part of the container such as soda bottles, milk jugs, laundry bottles, vinegar containers, shampoo, conditioner, etc...

Paper/Cardboard: Clean cardboard and paper such as magazines, books, junk mail, envelopes, phone books, catalogues, writing paper, newspaper, and shredded paper placed in a grocery bag in your recycle cart. All cardboard must be cut to fit into your recycle cart.

The following are items **not acceptable** for single stream recycling and should be put in your grey solid waste (trash) cart:

- Paper that is contaminated with food grease or debris; Tissue products, gift wrap, and foil
- Clay flower pots, ceramic cups and plates, drinking glass and dinner ware; pots, pans and ovenware; Styrofoam, and microwave containers
- Light bulbs, window glass and auto glass
- Paint cans with dried sludge or dried paint;
- Sheet metal, screws and nails; car parts and small appliances
- Plastic bags, yogurt and cottage cheese type containers
- Motor oil bottles, solvent or chemical containers; empty pesticide and herbicide containers

Proceedings of the Reedsville Village Board
October 31, 2013

A meeting of the Reedsville Village Board was called to order on October 31, 2013 at 6:30 PM by Village President Andy Bubolz. Present were: Bob Campana, Ryan Lorrigan, Mary Olson, Jerry Reis, and Jack Siebert. Also present were: Brad Busse, Melanie Hills, Leroy Krepline, Craig Schuh, Andrew Pantzlaff, Joe Tisler and Jeremy Foytik

The minutes of the previous meeting of October 17, 2013 were approved as presented.

A motion was made by Olson and seconded by Campana to pay the accounts payable in the amount of \$129,795.64. Motion carried 5-0.

A motion was made by Siebert and seconded by Olson to send a check of \$50.00 to Wm Hillmann for helping with the compost pile while the tractor was being repaired. Motion carried 5-0. Following a discussion a motion was made by Reis and seconded by Campana to put up Christmas decoration on every other pole for only 6 hours starting December 1st and only putting up the display on the east end of the Village limits. Motion carried.

Hills presented the First Responders written monthly report

Tisler presented the Police Department written monthly report

Busse gave an update on the cross connection program and the actual readings done at the end of October. He will be contacting the Dept. of Natural Resources for assistance on the Cross Connection Report and will be reading the meters monthly starting November 2013.

Busse explained the process for when he is on vacation with MCO Busse presented a report showing why the Fire Department budget could not be cut. Following a discussion, it was mutual decided, that the Fire Dept 2014 budget would be \$136,000. Due to other commitments, the meeting with the Fire Dept and Fire Fighters officers was changed to Wednesday, November 13, 2013 at 6:30 pm. .

Krahn gave an update on the vacant lot concern and the 2014 proposed budget. A motion was made by Olson and seconded by Lorrigan to accept the recommendation from the insurance company and send the Disallowance of Claim letters. Motion carried 5-0. A motion was made by Lorrigan and seconded by Reis to have Step II water rates go into effect on December 20th, 2013. Motion carried 5-0. Following a discussion, a motion was made by Olson and seconded by Reis to include the increased Public Fire Protection Fees in the budget. Motion carried 5-0.

A motion was made by Olson and seconded by Reis to approve the vacation request from an employee. Motion carried 5-0. Pay Request #2 & Final was presented for approval from Wood Sewer and Excavating in the amount of \$102,725.82. A motion was made by Reis and seconded by Lorrigan to approve the pay request as presented. Schuh asked that the check be held until he receives the final papers from the sub-contractors. Motion carried 5-0. Amendment #2 for the Manitowoc Street Bridge project was presented in the amount of \$2,093.85 from Ayres Associates for approval. A motion was made by Olson and seconded by Lorrigan to approve the Amendment as presented. Motion carried 5-0. The 2014 Agreement from Eastshore Humane Association Inc was presented for approval. A motion was made by Campana and seconded by Reis to approve the Agreement as presented. Motion carried 5-0. Correspondence was presented from the WI Dept of Transportation regarding the proposed improvement project. The next regular meeting will be held on Thursday, November 21, 2013 at 6:30 PM. A motion was made by Reis and seconded by Lorrigan to adjourn the meeting. Motion carried 5-0. Meeting adjourned at 8:30 PM.
