

Mr. Butturini received a quote for the actual lights they want to install. We are just waiting for the quote for the actual installation of these lights. We are hoping that they will not need a whole lot more to complete the project. We will update everybody in the Annual Newsletter in fall of 2016.

Payment of Property Taxes:

- Real estate and personal property tax payments can be made in person at the Reedsville Municipal Building during normal business hours.
- Payments may also be made by sending a check to the following: Reedsville Municipal Building, Tax Collection, 217 Menasha St., Reedsville, WI 54230-8597. Taxes paid by check or money order must be made payable to the Village of Reedsville. **Cash will not be accepted.** A receipt will only be sent back if you have included a self-addressed stamped envelope.
- You can pay your taxes on-line at <https://client.pointandpay.net/web/VillageofReedsvilleWIWeb> This address can also be found on the Reedsville Website under Links.

All first installment taxes are due on or before January 31, 2016.

Cat & Dog Licenses: Unspayed females and unneutered males are \$10.00 each. Spayed females and neutered males are \$5.00 each. You must show proof of a valid rabies shot. Please make out a separate check for the licenses as it goes into a different account.

Holiday Tree Drop-off: Manitowoc County residents and business may drop off their natural holiday trees at the Basswood Compost Site from 7:00 am to 4:00 pm, Monday through Friday, and Saturdays from 8:00 am until noon. Please remove all ornaments, tinsel, lights, stands and storage bags before dropping off. If the tree is more than 6 feet long, it must be cut in half. The Basswood compost is located at 3000 Basswood Rd., near the intersection of County Road P and R. Call 683-4333 or visit www.manitowocrecycles.org for additional information. **The Village does not pick up or chip Christmas Trees**

Snow & Ice Removal: The owner or occupant of any lot abutting on a public sidewalk shall clear their sidewalk of snow within twenty-four (24) hours after a snowfall and keep the same free of ice. If such snow or ice is not removed as required herein, the Street Dept. shall cause the same to be done and the cost thereof assessed against the property owner

Utility Bill Payment Services:

You can use your credit/debit card or go on-line at

- You can have your utility payment deducted automatically from your checking or savings account. The application form is available on the website under *Forms and Permits*, in the Reedsville Municipal Building lobby or the Denmark State Bank – Reedsville office.

Building Permits: A building permit is required for any structural or major changes in excess of \$300.00 to your home or property. Permits cost \$20.00 for the first \$2,000 of material and labor costs and \$2.00 for each additional \$1,000 of costs after that. Building Permits are good for 6 months. The application form is available on the website under *Forms and Permits* or in the Reedsville Municipal Building lobby. Permits can be obtained at the Clerk-Treasurer office located at 217 Menasha Street.

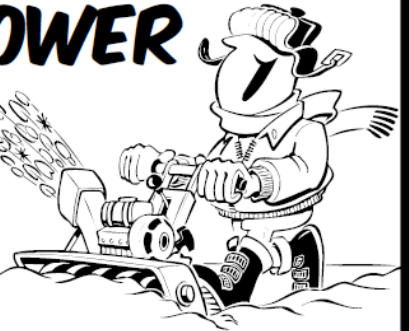

January is Birth Defects Prevention Month By Denise Brilliant, NP

Birth defects are common, costly and critical. Every 4½ minutes, a baby is born with a major birth defect. Women are encouraged to take steps to reduce the risk of certain birth defects. Unfortunately, not all birth defects can be prevented. Women can, however, lower their risk of having a baby born with a birth defect by following some basic health guidelines throughout their reproductive years.

Women are encouraged to make a **PACT** for their own health and the family they may one day have. These preventive steps can help reduce the number of birth defects:

Plan ahead:

- Get as healthy as you can before you get pregnant.
- Get 400 micrograms (mcg) of folic acid every day.

Avoid harmful substances:

- Avoid drinking alcohol and smoking.
- Be careful with harmful exposures at work and home.

Choose a healthy lifestyle:

- Eat a healthy diet (fruits, vegetables, whole grains, low fat dairy, lean proteins, and healthy fats and oils)
- Be physically active.
- Get medical conditions like diabetes under control.

Talk to your provider:

- Have a medical checkup.
- Discuss all medications, both prescription and over-the-counter.
- Discuss your family history.

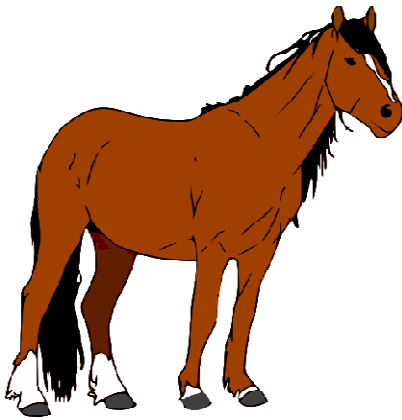
