Schedule your child's back-to-school physical today

Although it's hard to believe, summer is quickly approaching the halfway mark. Both parents and children are enjoying a well-deserved break from the hectic, school-year routine.

Before the rush of back-to-school preparations gets into full swing, consider scheduling your child's back-to-school physical in the next few weeks. Routine health screenings for school-age children are very important.

Back-to-school checkups are the only visit some children, especially teens, will have with a health care provider all year. A health maintenance exam involves much more than having a provider sign a permission card to meet school or WIAA requirements for participating in organized sports.

A back-to-school exam includes a thorough medical check-up, review of immunizations and time to talk about any developmental issues that the child may be facing.

The annual exam gives the health care provider an opportunity to offer advice and information on important topics such as proper nutrition and exercise. The provider can also offer counseling on important safety and injury prevention topics, such as the age-appropriate use of booster seats, seat belts, bike helmets and sunscreen.

In addition to addressing health issues, it gives health care providers a chance to talk with adolescents about making healthy lifestyle choices, such as avoiding drugs, tobacco products and alcohol. Health care professionals may also ask specific questions to screen teens for depression.

To ensure the highest quality of continuity and medical care, every child should have a primary care provider and a 'medical home'. Keep in mind that developing a long-term relationship with a child or adolescent gives the health care provider greater awareness of that child's progress and development by knowing his or her medical history. This helps health care providers detect any new problems that may be emerging. 
The parent portion of the WIAA sports physical form must be completed and signed prior to the visit.

From the Village Hall

Cell Phones vs. Land Line Phones: Many people no longer have a land line (Frontier) phone in their homes. Cell phones are used in place of regular phones. If this is the case, please call the Village-Clerk's office at 754-4371 and let us know your phone number. In case of an emergency, such as a water main break where we may have to turn off your water, we need to get in touch with you. If we do not have updated phone numbers, we cannot reach you and that could be a problem. Even if you have a land line phone and a cell phone, it would be helpful to have both phone numbers on file. Thank you.

Consumer Confidence Report: Copies of the Consumer Confidence Report, water/sewer rate sheet, direct deposit sheet, refuse collection sheet <u>and the June water bill</u> were mailed to all utility customers in a small manila envelope at the end of June. If you have any questions, concerns or need additional copies of any of these sheets, please stop in the Clerk-Treasurer office during normal business hours.

Reminder – Pool Owners: You must fill out the **Swimming Pool Discount Application** to qualify for the swimming pool discount. No other form of submittal will be accepted. This form can be picked up at the Reedsville Municipal Building Lobby.

Open Burning/Fire Pits: All fires must be monitored by a responsible person until the fire has extinguished itself completely. Only clean wood may be used in fire pits and flames cannot extend more than two feet (2') above the pit. Controlled burning must be located off the public street pavement or street gutter, must be as least fifteen (15') from any lot line and may not be less than fifteen feet (15') from any building. Persons utilizing and maintaining outdoor fires shall be responsible for any liability resulting from any damage caused by their fire.

Curfew: Any person under the age of 18 unaccompanied by a parent or legal guardian may not be out and about between 11:00 pm-6:00 am Sunday through Thursday and 12:00 am-6:00 am, Friday and Saturday. **Bicycle Registration:** All bicycles must be registered. To obtain the license, flag down a Village Police Officer. A \$2.00 fee covers a one-time registration.

Defecation on Private or Public Property: It shall be unlawful for any person owning or in control of a dog or cat to allow or permit such animal to defecate on any private or public property owned by another person. Violation of this shall be punishable by a forfeiture of anywhere from \$20.00 to \$200.00 **Last installment of your real estate taxes**: The Manitowoc County Treasurer, Cheryl M. Duchow, is reminding taxpayers that July 31st is just around the corner and this means the last installment of your real estate taxes is due. Contact the Manitowoc County Treasurer's Office or go to the County website at www.manitowoc-county.com if you are unsure of the amount of taxes due. Along with your check, please mail in the 2nd installment tax stub with your payment to assure that your payment is applied to the correct parcel. Make certain that your payment is postmarked by July 31st. Please include a self-addressed, stamped envelope when requesting a receipt.

Proceedings of the Reedsville Village Board

June 4, 2012

A meeting of the Reedsville Village Board was called to order on June 4, 2012 at 6:30 PM by Village President Ritalyn Schuh. Present were: Andy Bubolz, Bob Campana, Mary Olson, Marybeth Rabideau, Jerry Reis, and Jack Siebert. Also present were: Brad Abplanalp, Brad Busse, JoAnn Mignon, LeRoy Krepline, Cory Kiekhaefer and Andy Pantzlaff.

At 7:30 pm, a motion was made by Reis and seconded by Olson to convene into closed session, pursuant to WI Statute Section 19.85(1)(b) to conduct business which requires a closed session to consider dismissal, demotion, licensing or discipline of any public employee.. Motion carried 6-0.

At 8:09 pm a motion was made by Olson and seconded by Siebert to reconvene into open session. Motion carried 6-0.

The minutes of the previous meeting of May 21, 2012 were approved as presented.

A motion was made by Olson and seconded by Campana to pay the accounts payable in the amount of \$33,904.00. Motion carried 6-0.

President Report: None **Committee Reports**:

Public Safety: Fire – Written Report, Police Dept – Written Report. A motion was made by Campana and seconded by Reis to purchase patches for the Police Dept in an amount not to exceed \$150.00. Motion carried 6-0.

Park & Recreation: Following a discussion it was decided that it would not be appropriate to name the hardball field. A motion was made by Campana and seconded by Reis to decline the request. Motion carried 6-0. A motion was made by Reis and seconded by Olson to donate \$200.00 to the Garden Club. Motion carried 6-0.

Public Works: A motion was made by Campana and seconded by Olson to submit the application for the Creek Dredging Permit with the Dept. of Natural Resources. Motion carried 6-0. A motion was made by Reis and seconded by Campana to send a letter to Wm Bratz concerning the ditch on Mill St. Motion carried 6-0.

Public Utilities: Written. Resolution 2012-1 approving the 2011 CMAR was introduced by Campana. A motion was made by Reis and seconded by Rabideau to approve the Resolution as presented. Motion carried 6-0. A motion was made by Bubolz and seconded by Olson to refund Bauknecht \$991.35 for charges paid after disconnection notice. Motion carried 6-0. A motion was made by Bubolz and seconded by Siebert to refund Bauknecht \$169.61 for charges that were for the previous owner. Motion carried 6-0.

General Government: A motion was made by Olson and seconded by Campana to set up a special meeting for June 11, 2012 at 6:30 pm to tour Village projects/concerns, discuss the Village President position and for personnel. Motion carried 6-0.

Finance: Resolution 2012-2 changing the 2012 budget for the Mud Creek Bridge Replacement Project was introduced by Reis. A motion was made by Campana and seconded by Olson to approve the Resolution as presented. Motion carried 6-0. Resolution 2012-3 changing the 2012 budget to purchase the International Truck was introduced by Siebert. A motion was made by Reis and seconded by Rabideau to approve the Resolution as presented. Motion carried 6-0

The next regular meeting will be held on June 18, 2012 at 6:30 PM. A motion was made by Reis and seconded by Rabideau to adjourn the meeting. Motion carried 6-0. Meeting adjourned at 8:45 PM.
