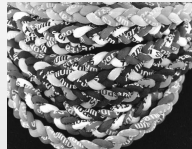

### From the Village Hall

**We still need your help!** Please contact the Clerk-Treasurer's office to see if you need a new remote water meter installed. We would like to be able to do **monthly meter readings** in fall but to accomplish this we need all customers to have the new meters. The Dept. of Natural Resources also requires all homes to have a cross connection inspection done so they will be doing this at the same time.

**Cell Phones:** If you have switched to cell phones, please contact the Village-Clerk's office and let her know your cell phone numbers.

**Clerk/Treasurer's Office Hours:** Monday thru Thursday, 8:00 am to 3:00 pm and Friday, 8:00 am to 1:00 pm. Office is located at the Reedsville Municipal Building, 217 Menasha Street. Phone number: 920-754-4371, E-mail address: [clerk-treasurer@reedsville.org](mailto:clerk-treasurer@reedsville.org)

**Open Burning/Fire Pits:** All fires must be monitored by a responsible person until the fire has extinguished itself completely. Only clean wood may be used in fire pits and flames cannot extend more than two feet (2') above the pit. Controlled burning must be located off the public street pavement or street gutter, must be as least fifteen (15') from any lot line and may not be less than fifteen feet (15') from any building. Persons utilizing and maintaining outdoor fires shall be responsible for any liability resulting from any damage caused by their fire.

**Curfew:** Any person under the age of 18 unaccompanied by a parent or legal guardian may not be out and about between 11:00 pm-6:00 am Sunday through Thursday and 12:00 am-6:00 am, Friday and Saturday.

**Bicycle Registration:** All bicycles must be registered. To obtain the license, flag down a Village Police Officer. A \$2.00 fee covers a one-time registration.

**Defecation on Private or Public Property:** It shall be unlawful for any person owning or in control of a dog or cat to allow or permit such animal to defecate on any private or public property owned by another person. Violation of this shall be punishable by a forfeiture of anywhere from \$20.00 to \$200.00

**Last installment of your real estate taxes:** The Manitowoc County Treasurer, Cheryl M. Duchow, is reminding taxpayers that July 31<sup>st</sup> is just around the corner and this means the last installment of your real estate taxes is due. Contact the Manitowoc County Treasurer's Office or go to the County website at [www.manitowoc-county.com](http://www.manitowoc-county.com) if you are unsure of the amount of taxes due. Along with your check, please mail in the 2<sup>nd</sup> installment tax stub with your payment to assure that your payment is applied to the correct parcel. Make certain that your payment is postmarked by July 31<sup>st</sup>. Please include a self-addressed, stamped envelope when requesting a receipt.

**Pool Owners:** You must fill out the **Swimming Pool Discount Application** to qualify for the swimming pool discount. No other form of submittal will be accepted. A fill-in application can be found on the Reedsville Website at [www.reedsville.org](http://www.reedsville.org) under the forms tab or picked up at the Reedsville Municipal Building Lobby.

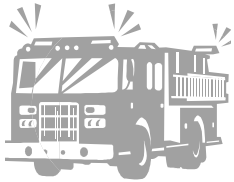

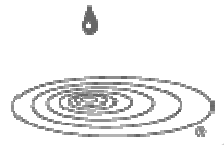

## Understanding Gastric Ulcers

Ulcers are open sores that develop on the inside lining of the esophagus, stomach and upper portion of the small intestine. The most common symptom of an ulcer is abdominal pain caused by stomach acid coming into contact with unprotected tissue.

Eating generally decreases ulcer pain temporarily because food neutralizes the acid. As soon as the food begins to be digested, the pain returns.

Many ulcers are caused by a bacterial infection, often *Helicobacter pylori*. Ulcers also develop and may bleed due to overuse of NSAID pain relievers such as ibuprofen or naproxen.

Symptoms of an ulcer may include:

- burning pain in the gut that feels like a dull ache and comes and goes
- pain that often starts two to three hours after a meal and goes away after eating
- pain in the middle of the night when your stomach is empty

Other symptoms are:

- Nausea
- Abdominal indigestion
- Vomiting, especially blood
- Blood in stools or black, tarry stools
- Unintentional weight loss
- Fatigue
- Losing weight
- Loss of appetite
- Pain while eating

Some ulcers will heal if you avoid NSAIDs, alcohol and tobacco.

Other treatment options include medications to:

- Stop your stomach from making acid
- Kill the bacteria that is causing your ulcer

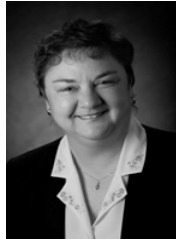
Steps to prevent ulcers from forming include:

- Stop using NSAIDs
- Don't smoke
- Don't drink alcohol

See your provider if you think you may have an ulcer or have any of the above symptoms, since ulcers can successfully be treated.

## DRUGS & NUTRIENT DEPLETION

### Vitamin B3 (Niacin)

Niacin, also known as vitamin B3, is an essential, water-soluble vitamin and needs daily supplementation. The classic deficiency syndrome associated with niacin depletion is known as pellagra ("rough skin"). Niacin depletion causes dermatitis, dementia and severe diarrhea. If there is a shortfall of niacin, energy reactions are blocked. Niacin protects the skin, nervous tissue and the digestive tract. Signs associated with shortages of vitamin B3 (niacin) are weakness, fatigue, occasional diarrhea, abdominal discomfort, apathy, mild memory problems associated with aging. Medications that deplete vitamin B3 are: anti-diabetic medication, aspirin, gallbladder medication, seizure medication, blood pressure medication, cholesterol medication, kidney medication, arthritis medication, gout medication.

Top food sources of niacin are:

- 3 oz. chicken breast = 17 mg
- 3 oz. tuna, canned = 15 mg
- 3 oz. liver = 12 mg
