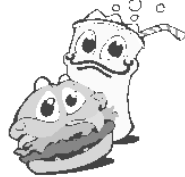

NEW Starting in June your water bills will be coming in an envelope format instead of the post-card. Please watch for it; it will have the **Village of Reedsville, 217 Menasha St**

Clerk-Treasurer's office will be closed June 3rd until June 14th, 2013. The Police Dept can be reached at 754-4656, Utility Dept 754-4094, Leroy 323-1466, Cory 323-0980, or leave a message on the answering machine at 754-4371, and she will return your call when she returns.

Update on Remote Readers (water meter) installation. We need your help! If you have vacation or have some scheduled time off in the next few months, please call us to set up an appointment to install the new meter. It takes about 30 minutes and you are without water during that time. They will be doing a cross connection inspection at the same time which is a Dept. of Natural Resources requirement. We would like to be able to do **monthly meter readings** in fall but to accomplish this we need to install the new meters.

Cell Phones: Again we need your help! With more households switching to cell phones, it is getting harder for the Village offices to get in touch with you. If you have switched to cell phones, please contact the Village-Clerk's office at 754-4371 and let her know your cell phone numbers.

Street Closed: Park Street 150 feet south of Manitowoc Street until 150 feet north of Green Meadow Drive will be closed Friday, June 28, 2013 until Sunday, June 30, 2013 for the annual Fire Fighters picnic.

Grass clipping are not to be blown on Village Streets or put into the Creek. Yard waste such as grass clippings, leaves, and yard & garden waste shall be disposed of by composting the material or taking it to the Village compost site.

Operator Licenses: All Operator Licenses expire at midnight on June 30, 2013. Diabetic Foot Care

If you have diabetes, proper foot care is very important. Poor foot care may lead to amputation of a foot or leg. People with diabetes are more vulnerable to foot problems, because diabetes can damage your nerves and reduce blood flow to your feet.

The American Diabetes Association estimates that one in five people with diabetes who seek hospital care, do so for foot problems. By taking proper care of your feet, most serious health problems associated with diabetes can be prevented.

Here are some diabetes foot care tips to follow.

Wash and Dry Your Feet Daily

Use mild soaps and warm water.

Pat your skin dry; do not rub. Thoroughly dry your feet.

After washing, use lotion on your feet to prevent cracking. Do not put lotion between your toes.

Examine Your Feet Each Day

Check the tops and bottoms of your feet. Have someone else look at your feet, if you cannot see them.

Check for dry, cracked skin.

Look for blisters, cuts, scratches or other sores.

Check for areas of redness, increased warmth, or tenderness.

Check for ingrown toenails, corns and calluses.

Cut toenails after bathing, when they are soft.

Cut toenails straight across and smooth with a nail file.

Avoid cutting into the corners of toes.

Do not cut your cuticles.

If you see that one or both of your feet have a sore, you should contact your health care provider immediately.

Reedsville Area Garden Club

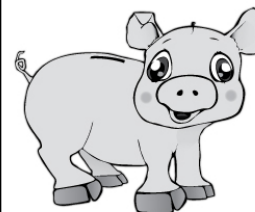

DRUGS & NUTRITION DEPLETION

All of the following information is from Clell's book and from the Natural Health manual:

Vitamin B2 (Riboflavin)

Riboflavin, also known as vitamin B2, is an essential, water-soluble B vitamin. B2 helps metabolize carbohydrates, fats, proteins. Used for making red blood cells. Essential for absorption of B3 and B6. The more active you are, the more you need.

Medications that deplete vitamin B2 (Riboflavin):

Oral contraceptives, tricyclic anti-depressants, phenobarbital, gout medication.

Riboflavin deficiency causes a breakdown in the skin, eyes and mucous membranes of the intestinal tract. Depletion can cause altered nutrient absorption from the intestinal tract, dry skin, cracks in the corners of the mouth, inflamed mucous membranes, lip soreness, lip burning, tongue burning, scaly skin, eczema, depression and hysteria.

SAFETY TIPS FROM THE REEDSVILLE POLICE DEPARTMENT

Spring has finally arrived and with it you may have some home improvement projects or maintenance issues you need to take care of. If so we want you to be safe and know how to protect yourself from any scams. Recently we had several questions about a company wanting to do work in the Village. The company was checked through the Bureau of Consumer Protection and found to be a legitimate company. At this time of year many people are receiving mailings or offers for service so here are some ways to protect yourself.

If you need to have work done on your home or property

1. Contact a local business.
2. Get recommendations from friends and neighbors about companies they have previously used.
3. If you have questions about a company or mailing you receive you may Contact the Bureau of Consumer Protection to find out if there are complaints on file against the contractor.

Unfortunately there are people out there who may try to scam you. As sure as the summer brings tourists to Wisconsin, it also brings transient home improvement workers and scams and these rip-off artists may try to hit our community. Transient contractors specialize in blacktopping driveways, installing lightning rods, painting, roofing and siding. Their work and materials are inferior and they are likely to steal from you. Transients hit an area, take the money, and run. Frequently they know the quickest route to the banks in your area to cash checks. It is not always wise to hire an unknown door-to-door seller for home improvement work.

If transients come to your door:

1. Don't give into their high-pressure tactics.
2. Don't let them in your home.
3. Ask if they have a seller's permit if they do not close the door and contact the police department at (920) 754-4656.

If you have not called for someone to come and look at your home or property you do not have to answer the door. If you do speak with them do not let them into your home as many are experts at finding and taking valuables. If you are able to safely write down the make and model of their vehicles or get a license plate numbers do so and alert local law enforcement. Call the police immediately if anyone begins to do a job without your authorization.

If you need home improvements there are many reputable companies in our area. Contact them on your own.

To further protect yourself always read all the information printed on any contract and know what is covered and what is not before signing anything.
