Operator Licenses: All Operator Licenses expire at midnight on June 30, 2016. Medicare wants to keep you well

Preventive services are important because they can find health problems early — when treatment works best.



It's important to understand which preventive services Medicare covers 100% and which health care services you may end up paying for.

All Medicare participants are eligible for a yearly wellness exam called a Medicare Wellness Visit. Once you are covered under Medicare Part B, you should have this visit to develop or update a personalized prevention plan to help prevent disease and disability, based on your current health and risk factors.

Your provider may ask you to complete a "Health Risk Assessment" as part of this visit. This visit is covered at 100% once every 12 months (11 full months must have passed since the last visit). The Part B deductible doesn't apply.

However, if your health care provider performs additional tests, exams for problems or chronic health care issues or services during the same visit, these services aren't covered

under the preventive benefits but rather under your regular Medicare coverage.

You will pay your coinsurance and Part B deductible for that portion only.

If you ask your health care provider for a complete physical — which is a more comprehensive exam that includes tests based on blood work — Medicare won't cover it. It's important to ask for the correct type of exam when you make your appointment.

CLINICAL STUDIES FINALLY PROVE: SUPPLEMENTS = SUCCESS

While the debate on whether "dietary supplements actually work" continues to dominate the headlines, Chief Science Officer, Dr. Matthew Tripp and a team of scientists at The Hughes Center for Research and Innovation decided to stop talking and start testing. - . 65% more fat loss
- . 125% greater reduction in systolic blood pressure
- . 62% greater reduction in diastolic blood pressure
- . 66% greater reduction in triglycerides
- . 129% greater reduction in total cholesterol
- . 80% greater reduction in LDL cholesterol
