## March is National Colorectal Cancer Awareness Month

Among cancers that impact both men and women, colorectal (cancer of the colon or rectum) is the second leading cause of cancer deaths in the United States, according to the CDC. Every year, about 140,000 Americans are diagnosed with colorectal cancer, and more than 50,000 people die from it.

The risk of getting colorectal cancer increases with age and a family history of having colon cancer. More than 90% of cases occur in people 50 years old or older. Colorectal cancer screening saves lives, but many people are not being screened.

If you're 50 or older, getting a screening test for colorectal cancer could save your life. If you have a family history of colon cancer, you should be screened earlier. Discuss at what age you should begin screening with your health care provider.

Here's how a screening test could save your life:

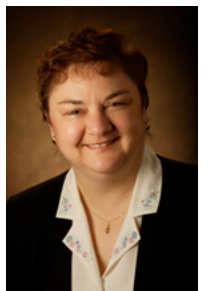
- Colorectal cancer screening tests can find precancerous polyps so they can be removed before they turn into cancer. In this way, colorectal cancer is prevented.
- Screening tests also can find colorectal cancer early, when treatment can lead to a cure.

Precancerous polyps and colorectal cancer don't always cause symptoms. You could have polyps or colorectal cancer and not know it. That's why having a screening test is so important.

Possible symptoms for colorectal cancer include:

- Blood in the stool
- Stomach pain, aches, or cramps that persist
- Unexplained weight loss.

These symptoms may be caused by something other than cancer. If you're having any of these symptoms, the only way to know what is causing them is to see your health care provider.

Busse presented the Utility Department written monthly report. He also gave an update on the main water break, GIS project and the Dept. of Natural Resources requirements.

Busse presented the Fire Department written monthly report. He also gave an update on the new Fire Truck and appointing Todd Maertz as the new Assistance Chief. Bubolz will contact the Towns about unsigned Fire Protection Agreements. A motion was made by Siebert and seconded by Lorrigan to purchase new radios for the new truck from Frank's Radio Service in the amount of \$4,849.60. Motion carried 5-0. A motion was made by Olson and seconded by Reis to purchase a leaf blower for the Fire Dept from Valu-Pro Power Center in the amount of \$190.00. Motion carried 5-0.

At 7:15 pm a motion was made by Campana and seconded by Reis to convene into closed session, pursuant to WI Statute Section 19.85(1)(f) to consider data of specific persons. Motion carried 4-0. At 7:30 pm a motion was made by Siebert and seconded by Reis to reconvene into open session. Motion carried 4-0.

A resident expressed his concern on his past bills prior to the installation of the new meter. The discussion on his request was postponed until the information can be reviewed by the Utility Dept.

Hills gave an update on the number calls for 2013 and the addition of new First Responders.

Busse gave an update on the water break and utility accounts. He also presented correspondence on an insurance letter that has been sent to property owners.
