From the Village Hall

Village Board meetings have been changed. They will be held on the 1st Thursday of each month. Starting time remains at 6:30 pm.

Cat & Dog Licenses are due on or before April 1st. Unspayed females and unneutered males are \$10.00 each. Spayed females and neutered males are \$5.00 each. You must show proof of a valid rabies shot.

Failure to obtain a license by April 1st, will result in a late fee of \$15.00 per pet.

Utility Bills, Parking Tickets and Reedsville News Advertising Fees: You can use your credit/debit card to pay these charges. The Village of Reedsville has partnered with *Point & Pay* for this service. They are located at: <https://client.pointandpay.net/web/VillageofReedsvilleWIWeb>. This address can also be found on the Reedsville Website under Links.

Water Softeners: Any water softener installed must be rated to have a salt efficiency of at least 4000 grains of hardness removed per pound of salt used, must be approved and inspected by a representative of the Village of Reedsville and must regenerate on demand only.

Clerk/Treasurer's Office Hours: Monday thru Thursday, 8:00 am to 3:00 pm and Friday, 8:00 am to 1:00 pm. Office is located at the Reedsville Municipal Building, 217 Menasha Street. **NOTE:** Clerk-Treasurer's Office will be closed March 16th thru March 20th, 2015

Solid Waste & Recycling Carts need to be out on the curb by 5:00 am for service. **DO NOT** place carts within 4' ft of any objects such as utility poles, mailboxes, or vehicle. Carts need to be on separate sides of your driveway or at least 4' apart. Carts placed on the street or on snow banks will not be serviced.

Colorectal cancer: What you really need to know

Current statistics from the American Cancer Society indicate that about 150,000 Americans are diagnosed with colorectal cancer, and more than 50,000 people die each year from it.

A high percentage of colorectal cancers could be avoided if everyone over age 50 had regular screening tests. Yet despite the obvious benefits, fewer than half of Americans 50 or older have been screened for this disease.

Colorectal cancer can often be prevented by removing precancerous polyps (growths) found during a colonoscopy — considered the "gold standard" of colorectal screening procedures. Removing precancerous polyps before they turn cancerous actually prevents the disease from ever developing.

Aurora Health Care recommends that everyone age 50 and older be screened in one of the following ways:

- Colonoscopy every 10 years
- Fecal occult blood test every year (a simple test to find unseen blood in the stool)
- Flexible sigmoidoscopy every five years
- Both the fecal occult blood test (every year) and sigmoidoscopy (every five years)
- Double contrast barium enema every five years

People at higher risk for colorectal cancer, or those with a family history of the disease, may need to have these tests done earlier and more often.

If you're 50 or older, be sure to talk with your health care provider about colorectal cancer screening. Taking this important step could end up saving your life.

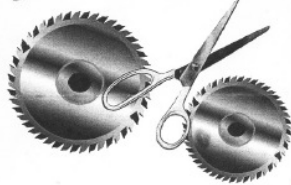
