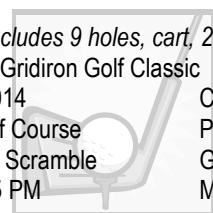

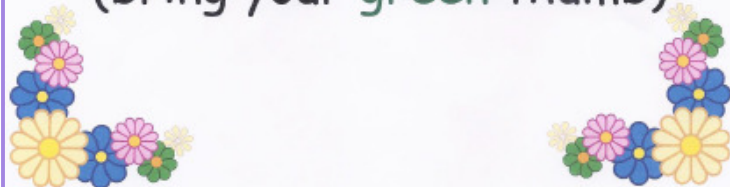

## From the Village Hall

**Thank You:** On behalf of the Village Board, Village Employees and citizens of the Village, I would like to thank Mary Olson for her time and energy while Village Trustee and sometime acting Village President. We wish you well on all your future plans!

**Bicycle Registration:** All bicycles must be registered. To obtain the license, flag down a Village Police Officer. A \$2.00 fee covers a one-time registration.

**Curfew:** Any person under the age of 18 unaccompanied by a parent or legal guardian may not be out and about between 11:00 PM - 6:00 AM Sunday through Thursday and 12:00 PM - 6:00 AM Friday and Saturday.

**Vehicle Nuisance:** It is illegal for any partially dismantled, non operating, wrecked, junked, unregistered or discarded vehicles to be placed or stored on any public or private property within the Village limits for a period of longer than five (5) days, unless said vehicles are stored within an enclosed building. This ordinance does not apply to property zoned for the sale or repair of vehicles. Having a vehicle behind your garage or under a tarp does not meet the requirement of an enclosed building.

**Open Burning/Fire Pits:** Controlled burning must be located off the public street pavement or street gutter, must be at least fifteen (15') from any lot line and may not be less than fifteen feet (15') from any building. Only clean wood may be used in fire pits and flames cannot extend more than two feet (2') above the pit. All fires must be monitored by a responsible person until the fire has extinguished itself completely. Persons utilizing and maintaining outdoor fires shall be responsible for any liability resulting from any damage caused by their fire.

**Pool Owners:** You must fill out the Swimming Pool Discount Application to qualify for the swimming pool discount. No other form of submittal will be accepted. This form can be found on the Reedsville website [www.reedsville.org](http://www.reedsville.org) or picked up at the Reedsville Municipal Building Lobby.

**Dogs Or Cats:** It shall be unlawful to own, harbor, shelter, or keep any dog or cat which runs at large within the limits of the Village. A dog or cat shall be deemed to be running at large when it is on any public street, alley, parks, or other grounds of the Village or any other premises in the Village other than the premises of its owner, his servant, agent or a member of his family of suitable age and discretion unless it is on a durable leash no longer than eight feet (8') or the dog or cat must be under control and within eight feet (8') of its owner, his servant, agent or a member of his family of suitable age and discretion at all times when off the premises of its owner.

**Dogs Or Cats:** It shall be unlawful for any person owning or in control of a dog or cat to allow or permit such animal to defecate on any private or public property owned by another unless such person shall remove all feces so deposited by such animal. Violation shall be punishable by a forfeiture of not less than twenty dollars (\$20.00) nor more than two hundred dollars (\$200.00).

- Don't spend long periods of time in direct sunlight, especially between 10 a.m. and 4 p.m.
- Wear hats with wide brims that protect your face and ears
- Wear long-sleeved shirts and pants
- Use a broad-spectrum sunscreen with an SPF of 15 or higher
- Apply sunscreen 30 minutes before you go out in the sun. Don't forget the ears and nose.
- Reapply sunscreen every 30 to 60 minutes, especially when swimming or during heavy perspiration
- Wear sunglasses (with UVA protection) to protect your eyes
- Use a lip balm with sunscreen
- Avoid tanning beds and sunlamps
- Show any unusual bump or changing mole to your health care provider
- Have skin checkups if you have a family history of skin cancer
