On Tuesday, September 16th, the Wisconsin Department of Public Instruction released the School Report cards for all public schools in the state of Wisconsin. The report card provides data on multiple indicators such as student achievement, student growth, closing gaps in reading and mathematics performance, and postsecondary readiness. The School Report card also measures performance on three student engagement indicators; test participation rate, absenteeism rate, and dropout rate. Each school in the district (such as elementary school, middle school, and high school) is given a score as well as the district as a whole. I am proud to report that the Reedsville School District received a score of "Exceeds Expectations." The Reedsville School District had the highest overall rating for all of the public schools in Manitowoc County and was ranked 4th out of the 37 schools in CESA #7 (CESA #7 covers most of the schools in northeast Wisconsin). Again, I say congratulations to the Reedsville School District Community for all of your support of our schools, staff, and students. This is something that all of us can be proud to announce.

- Nearly 30 million children and adults in the United States have diabetes.
- Another 86 million Americans have pre-diabetes and are at risk for developing type 2 diabetes.
- Recent estimates project that as many as one in three American adults will have diabetes in 2050, unless we take steps to stop diabetes.

Did you know?

- People with diabetes are nearly twice as likely to be hospitalized for a heart attack or stroke.
- Diabetes causes nearly 50% of all cases of kidney failure.
- More than half of all amputations in adults occur in people with diabetes.
- More than half a million American adults have advanced diabetic retinopathy, greatly increasing their risk for severe vision loss.
- About 60-70 percent of people with diabetes have mild to severe forms of nerve damage that could result in pain in the feet or hands, slowed digestion, sexual dysfunction and other nerve problems.

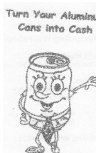
