**Sump Pumps:** No discharge or overflow of storm water shall be permitted upon any street or public way from **November 1** to April 1 of each year.

**Proceedings of the Reedsville Village Board**

August 10, 2017

The monthly meeting of the Reedsville Village Board was called to order on August 10, 2017 at 6:30 PM by Village President Andy Bubolz. Present were: Joe Cummings, Jerry Reis, and Jesse Walt; Absent: Jack Siebert. Also present were: Brad Busse, Melanie Hill, Leroy Krepline, JoAnn Mignon, Corey Hoppentrath, John Schuh, Joe Farwell, Michael Kocourek, Debbie Bauknecht, Tony Hill, Stacey Barth, Rick Krahn, Becky Busse, Jessica Pautz, Jason Reis, Yvonne Deyo, Richard Deyo, Delmar Knier, Sonia Collins, Laura & Harry Beutler, Casey Taddy, Jon Zapletal, and McKenzie Thiel.

A motion was made by Reis and seconded by Walt to approve minutes from the July 13, 2017 meeting as presented. Motion carried 3-0.

A motion was made by Reis and seconded by Cummings to pay the accounts payable in the amount of \$181,886.73. Motion carried 3-0.

Beutler informed the Board that they will be having their Grand Opening of the Latte' Da Coffee Café on August 27, 2017 from 6:00 am until 2:00 pm.

Correspondence was presented from Deyo Disposal, AT&T and Attorney Mozinski.

A motion was made by Cummings and seconded by Reis to approve the Soda License Application from TOPS. Motion carried 3-0. The Liquor and Soda License applications from the Reedsville Fire Dept. were tabled until the applications are returned.

The First Responders monthly written report was presented by M Hill. A motion was made by Reis and seconded by Cummings to include in both the First Responders and Fire Dept Standard Operating Guidelines that no family members may serve as officers on the Boards at the same time. Motion carried 3-0. Hill said the Knox box will be installed in the vehicle within a week and the First Responders who are not certified must retake the certification classes.

The Police Dept. monthly written report was presented by Mignon.

The Utility Departments monthly written report was presented by Hoppentrath. The discussion on the proposal from AT&T was postponed until the next regular scheduled meeting in order to review the offer. The WWTF exterior lighting replacement project has been postponed until the end of the year due to budget concerns. Bubolz approved the estimates from Speedy Clean (\$1,100 - \$1,400) and Crane Engineering (\$4,300.00) to clean and inspect the Lift Station with work to begin August 16, 2017. The discussion on water/sewer rates was postponed until the next regular scheduled meeting.

The Fire Dept. monthly written report was presented by Busse. A motion was made by Reis and seconded by Cummings to approve the Fire Protection

Agreement with the Town of Franklin. Motion carried 3-0.

The Public Works Dept monthly written report was presented by Krepline. A motion was made by Walt and seconded by Cummings to have John Schuh get certified to apply weed control on Village property. Motion carried 3-0. The discussion on the proposal from Deyo Disposal was postponed until the next regular scheduled meeting in order to review the proposal.

A motion was made by Cummings and seconded by Reis to have the owner and the building inspector discuss what will be done in the building located at 512 Menasha Street to see if it complies with the zoning. Motion carried 2-1 (Walt – Nay). A special meeting will be scheduled for August 16, 2017 at 6:30 pm to review the reports and make a final decision. Mignon will contact references on the legal service proposals. Reis introduced Ordinance 2017-2 regarding the changes in fees. A motion was made by Cummings and seconded by Walt to approve the Ordinance as presented. Motion carried 3-0. The discussion on the delinquent personal property taxes was tabled as the taxes have been paid in full.

A motion was made by Cummings and seconded by Reis to return to a 7 person Board. Motion carried 3-0. The officers for the Fire Dept and the First Responders will meet on August 23, 2017 at 6:30pm. Cummings and Reis will be the Board Members who will work on a new resolution documenting that the First Responders and the Fire Dept. are two separate entities, with their own Officers, districts and checkbooks and each entity must report to the Village Board. A motion was made by Cummings and seconded by Reis to approve the Purchase Policy as presented. Motion carried 3-0. A special meeting will be scheduled for Thursday, September 7, 2017 at 6:30 pm to work on the 2018 budget. Department Heads are asked to come with their proposed budgets and capital outlay proposals. More information will be obtained on building permit fees from surrounding municipalities.

A motion was made by Reis and seconded by Cummings to amend the agenda to add an item for a closed session after the President Report. Motion carried 3-0. At 7:50 pm a motion was made by Reis and seconded by Walt to convene into closed session pursuant to Sec 19.85 (1)(e) to consider the proposed settlement for which negotiating reason requires a closed session. Motion carried 3-0. At 7:56 pm a motion was made by Walt and seconded by Reis to reconvene into open session. Motion carried 3-0.

The next regular monthly meeting will be held on Thursday, September 14, 2017 at 6:30 PM. A motion was made by Walt and seconded by Reis to adjourn the meeting. Motion carried 3-0. Meeting adjourned at 8:05 PM.
