THE CRITICAL ROLE OF PROTEIN IN HEALTH

Why is protein so important? Proteins and the amino acids that form them are the chief building blocks of organic life and they are critical to both the structure and function of every cell.

Major protein uses: the structure of bones, muscles, skin, hair and cell membranes, neurotransmitters and many hormones are amino acid based, antibodies that aid immune responses are proteins, amino acids can be used as fuel for energy production. Hemoglobin is a protein. Protein requirements: the DRI (Dietary Reference Intake) is 0.36 grams per pound, so..

Babies need about 10 grams a day,

School-age children need 19-34 grams a day

Teenage boys need up to 52 grams a day

Teenage girls need 46 grams a day

Adult men need about 56 grams a day

Adult women need about 46 grams a day

This is a minimal amount for sedentary people. Athletes, pregnant women and nursing mothers need more. Optimal amounts may be much higher and higher protein intake (coupled with lower carbohydrate intake) may assist in weight management. Proteins must be broken down into free amino acids to be absorbed and utilized. HCl or enzyme deficiencies may result in poor assimilation of proteins.

Crave sugar? Losing muscle tone? Your protein may not be digesting properly due to lack of enzymes or acid blockers.

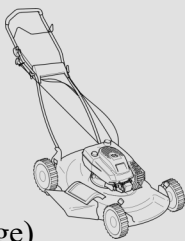

Is your child's backpack too heavy?

Back to school time is here, are there any guidelines to follow for heavy backpacks?

When used correctly, backpacks can be the best way for students to carry everything throughout the day. However, the American Academy of Pediatrics cautions that backpacks that are too heavy or worn incorrectly can cause back, neck, shoulder, and posture problems for students.

The AAP shares these guidelines for backpack safety.

Choose the right backpack

- Choose a pack with two wide, padded shoulder straps — Backpacks with one shoulder strap cannot distribute weight evenly. Narrow straps can cause pain and restrict circulation.
- Padded back — A padded back protects against sharp edges and increases comfort.
- Waist strap — This can distribute the weight of a heavy load more evenly.
- Lightweight backpack — The backpack itself shouldn't be heavy.
- Rolling backpack — Rolling backpacks are an option for students, but remember that they can be difficult to maneuver in harsh weather.

Tips to prevent injury

- Use both shoulder straps. Wearing one strap may increase curvature of the spine and strain muscles.
- Tighten the straps so that the pack is close to the body.
- Pack light. The backpack should never weigh more than 10 to 20 percent of the student's total body weight.
- Bend using both knees. Don't bend over with a heavy backpack.

Tips for parents

- Remove any unneeded items to keep the backpack light.
- Ask your child about any pain or discomfort they may have by carrying a backpack. If your child reports any pain, consult with your health care provider.

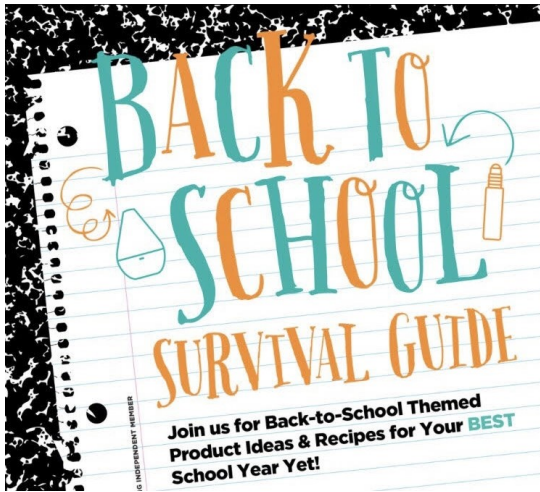

Proceedings of the Reedsville Village Board

June 8, 2017

The monthly meeting of the Reedsville Village Board was called to order on June 8, 2017 at 6:30 PM by Village President Geoff Weinreis. Present were: Joe Cummings, Jerry Reis, Jack Siebert and Jesse Walt. Also present were: Mike O'Connell, Melanie Hills, LeRoy Krepline, Corey Hoppenrath, Rob Michaelson, Craig Schuh, John Schuh, and Joe Tisler.

The minutes of the previous meeting of May 11, 2017 were approved as presented.

A motion was made by Siebert and seconded by Reis to pay the accounts payable in the amount of \$165,666.00. Motion carried 4-0.

At 7:15 pm a motion was made by Siebert and seconded by Reis to convene into closed

Session pursuant to WI Statue Section 19.85(1)(i) to conduct business which required a closed session to consider matters related to acts by businesses if discussed in public could adversely affect the business, its employees or former employees. Weinreis left the meeting. Motion carried 4-0. At 7:30 pm a motion was made by Reis and seconded by Siebert to reconvene into open session. Motion carried 4-0. Weinreis returned.

A motion was made by Siebert and seconded by Cumming to amend the agenda to present

the written Street Closure Application, to request (verbal) the fee for the closure be waved and to request (verbal) an exception to the park hours at the Firemen's Park for the picnic from the Reedsville Fire Fighters. Motion carried 3-0 Walt abstained. A motion was made by Siebert

the Street Closure Application will be submitted as specified on the Application. Motion carried 3-0 Walt abstained.

The First Responders monthly written report was presented by Hills. As the resignation

A motion was made by Siebert and seconded by Reis to approve the Temporary Class B Beer License Applications from the Holy Family Parish, Reedsville Fire Fighters and Reedsville Flames Youth Football. Motion carried 3-0. Walt and Cummings abstained, Weinreis voted.

A motion was made by Siebert and seconded by Walt to approve the Soda License Applications from Manitowoc Street Pub, Webster's Inn on Third Street LLC, Reedsville Athletic Assn, Country Vision Coop, Jim's Service and Car Wash, S&K Caf , Reedsville Lioness, Valu-Pro Power Center, Equity Coop, Holy Family Parish, Reedsville Fire Fighters, The Old Bar and the Reedsville Flames Youth Football. Motion carried 3-0. Cummings abstained.

A motion was made by Siebert and seconded by Cummings to approve the Tobacco License Application from the Country Vision Coop. Motion carried 4-0.

A motion was made by Siebert and seconded by Cumming to approve the Operator License Applications from: Pam Zahorik, Linda Wenzel, Thomas Wenzel, Paula Kliment, Rebecca Dvorachek, Sara Lemke, Patricia Schreiber, Tom O'Connell, Victoria Novy, Andrew Krueger, Danyl Haas and John Slo-ma. Motion carried 4-0.

Resolution 2017-3 authorizing the Storm Sewer Special Assessments for Deerview Drive was introduced by Reis. A motion was made by Siebert and seconded by Cumming to approve the Resolution as presented. Motion carried 4-0. Following a discussion a motion was made by Reis and seconded by Walt to approve the 2 year Operator License (effective August 1, 2017) and the fee schedule as presented. Motion carried 4-0. Weinreis gave an update on the

plagues for W.H. Noble. The bids for the legal services was postponed until the next regular scheduled Board meeting. Krahn explained she will be on vacation the week of July 10 thru the 14th. In order to have everything ready for the July 13, 2017 meeting she is asking that anything that needs to be on the agenda and any bills that need to be paid needs to be in her office by noon on July 5th. A discussion was held regarding participation in the Fire Fighter's parade.

An update was given on the 4th Street Bridge Project. Following a discussion a motion was made by Cumming and seconded by Reis to increase Schuh hours to 32 a week effective June 12, 2017. Motion carried 4-0.
