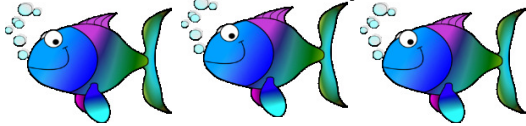

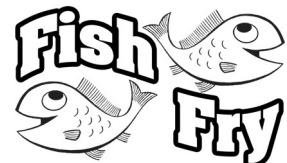

Country Visions Cooperative Announces Change for Service Garage

Reedsville, WI (February 6, 2017) At Country Visions Cooperative, the Board of Directors and Management team continually look for ways to improve the business. Many times, this involves change at some of the locations. Effective March 1st, 2017, the service garage, located in Country Visions Cenex C-Store facility at 511 South Calumet Street in Valders, will be leased to Valu Pro Power Center, LLC. Valu Pro is a small engine sales and service company owned by the Dave Bauknecht family located in Reedsville, WI. They were looking to expand their business and the Valders location fit into their plan. Valu Pro will continue to offer similar services to the customers of the garage, including the tire repair business, and bring their small engine expertise to Valders. Their top-notch service to their customers has created a successful business for the Bauknechts and that same service philosophy will be continued at the Valders shop.

This change does **not** affect the Cenex Convenience store or Subway in Valders. This part of the business will continue to be owned and operated by the Cooperative. The Cooperative's Board and Management believe this new business partnership will benefit both Country Visions and Valu Pro, as well as provide an expanded small engine business to the garage services the community has come to enjoy.

Cat & Dog Licenses are due on or before April 1st. Unspayed females and unneutered males are \$10.00 each. Spayed females and neutered males are \$5.00 each. You must show proof of a valid rabies shot. **Failure to obtain a license by April 1st, will result in a late fee of \$15.00 per pet.**

Utility Bills, Parking Tickets and Reedsville News Advertising Fees: You can use your credit/debit card to pay these charges. Water Softeners: Any water softener installed must be rated to have a salt efficiency of at least 4000 grains of hardness removed per pound of salt used, must be approved and inspected by a representative of the Village of Reedsville and must regenerate on demand only.

Honoring Someone Special

As the month of February comes to a close I recall how I celebrated Valentine's Day and observed President's Day. I remember back in grade school learning about George Washington and Abraham Lincoln and the fact they were both involved in wars, the Revolutionary War and Civil War respectively, and I wondered could George Washington and his army be considered the first veterans of our country? And what about Abraham Lincoln, did he have a military background as well? In researching this online I found out that Lincoln was a Captain during the Black Hawk War. So when remembering these two presidents this month one could also honor them as veterans for their military service.

Why do I make a point that these two men are veterans? It is because in February Valentine's Day was also celebrated, a day to show someone special how much you love them with a card or candy or flowers. But could something different have been done to show your love for that special veteran in your life by becoming a member of the American Legion Auxiliary and honoring their service for our country?

The American Legion Auxiliary (ALA) is the largest women's organization in the United States for veterans whose mission statement is, "In the spirit of service, not self, the mission of the American Legion Auxiliary is to support The American Legion and to honor the sacrifice of those who serve by enhancing the lives of our veterans, military, and their families, both at home and abroad. For God and Country, we advocate for veterans, educate our citizens, mentor youth, and promote patriotism, good citizenship, peace and security".

There are over 12,000 American Legion Auxiliary units throughout the United States. In Manitowoc County there are units located in Manitowoc, Reedsville, St. Nazianz, and Valders. These units help veterans locally, and within the county and state with donations raised from various events throughout the year including poppy distribution in May. Monetary donations are sent to scholarships that are sponsored through the ALA for members attending college and grants through the Homeless Women's Veteran Program are also supported by the ALA. Units send items to Camp American Legion and the veterans hospitals including stamps, toiletries, clothing, and many other items on their wish list, and there are numerous other ways the ALA assist veterans.

Now you may say I don't have time to attend another meeting or assist with a lot of activities, that's okay! A portion of the dues goes to various programs for veterans and their families within Wisconsin. The more members who belong to the ALA, the stronger our voices are to influence legislation affecting our veterans. So even if you don't have time to give right now, your membership dues do help veterans and their families, and then when the timing is right you will be able to volunteer to serve veterans through the ALA. 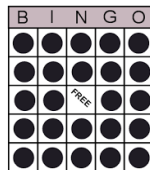

The monthly meeting of the Reedsville Village Board was called to order on December 8, 2016 at 6:30 PM by Village President Andy Bubolz. The minutes of the previous meeting of November 10, 2016 were approved as presented.

A motion was made by Reis and seconded by Walt to pay the accounts payable in the amount of \$225,230.56. Motion carried 3-0.
