From the Village Hall

Yard Waste: such as grass clippings, leaves, and yard & garden waste shall be disposed of by composting the material or taking it to the Village compost site.

Littering Street Prohibited: No person shall place, throw, deposit, dump, scatter, leave or permit to remain any rubbish, paper, stone, wire, manure, snow, ice, dirt, grass, leaves, construction or yard waste, dirt or filthy substance upon the street, gutter, sidewalk, alley or public ground in the village. Each owner or occupant of any building, dwelling house, store, shop, tenement or structure of any kind and description fronting or abutting on any street, sidewalk, gutter, alley or public ground shall clean the same by sweeping, scraping or shoveling such rubbish, dirt or filth from the sidewalk by or before twelve o'clock (12:00) noon of each day, and shall cooperate with the Public Works Dept. in keeping the streets, alleys, gutters and public grounds in a clean, tidy and orderly manner.

Operator Licenses: All Operator Licenses expire at midnight on June 30, 2018. Starting in 2018, Operator Licenses will be for 2 years. If you like to renew your license, a fill-in application can be found on the Reedsville Website at www.reedsville.org under the Forms & Permits tab or picked up at the Reedsville Municipal Building Lobby. You must submit a copy of your driver's license with the application. Cost of the license is \$25.00 for renewals and \$32.00 for new applicants

Pool Owners: You must fill out the Swimming Pool Discount Application to qualify for the swimming pool discount. No other form of submittal will be accepted. A fill-in application can be found on the Reedsville Website at www.reedsville.org under the Forms & Permits tab or picked up at the Reedsville Municipal Building Lobby.

Encouraging Men's Health/PCP ENCOURAGE THE MEN IN YOUR LIFE TO STAY HEALTHY

June is Men's Health Month. How can you help the men in your life stay healthy? Encourage them to build a relationship with a primary care provider (PCP) who can guide their health care and provide preventive health care to keep them healthy.

As a health care "quarterback," the PCP calls the plays and provides access to other health care services as needed. Being familiar with a man's health history helps a PCP effec-

tively handle most medical needs. This includes any short-term health issues, as well as chronic conditions, preventive care and screenings.

Do men need an annual exam?

Men should have an annual physical exam where a primary care provider checks weight, blood pressure, blood glucose levels and immunization status. Based on age and health history, certain cancer screenings may also be recommended such as prostate, colorectal, lung and skin cancer screenings.

Starting at age 20, men should be screened if they are at increased risk for heart disease. Starting at 35, all men need regular cholesterol testing. Men at average risk should be screened for Type 2 diabetes every three years, starting at age 45.

Regular preventive screenings help discover diseases at an early stage — even before symptoms appear — so they can be treated most successfully.

It's no surprise that healthier men live happier, longer lives. Growing evidence suggests that men (and their female counterparts) who maintain a strong, ongoing relationship with a primary care provider report greater satisfaction with their medical care and also enjoy better overall health.
