ORDINANCE TO AMEND SECTION 9-2-6 OF THE VILLAGE CODE OF ORDINANCES

ORDINANCE NO. 2018-4

REGARDING GOLF CART OPERATION

WHEREAS, Section 349.18 *Wis. Stat.* authorizes a Wisconsin municipality by ordinance to allow the operation of golf carts on any highway that has a speed limit of 25 miles per hour or less located within the municipality; and WHEREAS, the Village Board recognizes the need and convenience for residents to operate golf carts in the Village of Reedsville;

NOW THEREFORE, in the interest of public health, safety, welfare, and convenience, pursuant to Section 349.18 and Section 61.34, *Wis. Stats.*, and its police powers, the Village Board of the Village of Reedsville, WI hereby amends Title 9, Chapter 2 of the Village Code of Ordinances and ordains as follows:

1. Section 9-2-6 OPERATOR RESTRICTIONS (B), (C), and (D) are repealed.

2. Section 9-2-6 OPERATOR RESTRICTIONS (A) is amended and (B) is created as follows:

A. A person shall hold a valid Operator's license to operate a golf cart. No person whose operating license is under suspension, revocation, or cancellation may operate a golf cart.

B. Exemption: A golf cart shall be exempt from the registration requirement if the operator meets the definition of a person with a disability as described in Wis. Stats. Sec. 340.01(43g).

3. The terms of this ordinance are severable. If any provision hereof is found to be unenforceable or void by a court of competent jurisdiction, such finding shall not affect the remaining portions of this ordinance which shall remain in full force and effect.
