## **From the Village Hall**

### **Payment of Property Taxes:**

- Real estate and personal property tax payments can be made in person at the Reedsville Municipal Building during normal business hours.
- Payments may also be made by sending a check to the following: Reedsville Municipal Building, Tax Collection, 217 Menasha St., Reedsville, WI 54230-8597. Taxes paid by check or money order must be made payable to the Village of Reedsville. **Cash will not be accepted.** A receipt will only be sent back if you have included a self-addressed stamped envelope.
- You can pay your taxes on-line at <https://client.pointandpay.net/web/VillageofReedsvilleWIWeb> This address can also be found on the Reedsville Website under Links.

All first installment taxes are due on or before January 31, 2019.

**Cat & Dog Licenses:** Unspayed females and unneutered males are \$10.00 each. Spayed females and neutered males are \$5.00 each. You must show proof of a valid rabies shot. Please make out a separate check for the licenses as it goes into a different account.

**Holiday Tree Drop-off:** Manitowoc County residents and business may drop off their natural holiday trees at the Basswood Compost Site from 7:00 am to 4:00 pm, Monday through Friday, and Saturdays from 8:00 am until noon. Please remove all ornaments, tinsel, lights, stands and storage bags before dropping off. If the tree is more than 6 feet long, it must be cut in half. The Basswood compost is located at 3000 Basswood Rd., near the intersection of County Road P and R. Call 683-4333 or visit [www.manitowocrecycles.org](http://www.manitowocrecycles.org) for additional information. **The Village does not pick up or chip Christmas Trees**

**Clerk/Treasurer's Office Hours:** Monday thru Thursday, 8:00 AM to 3:00 PM and Friday 8:00 am to Noon 12:00 pm.

**Snow & Ice Removal:** The owner or occupant of any lot abutting on a public sidewalk shall clear their sidewalk of snow within twenty-four (24) hours after a snowfall and keep the same free of ice. If such snow or ice is not removed as required herein, the Street Dept. shall cause the same to be done and the cost thereof assessed against the property owner

### **Utility Bill Payment Services:**

**Building Permits:** A building permit is required for any structural or major changes in excess of \$300.00 to your home or property. Permits cost \$40.00 for the first \$2,000 of material and labor costs and \$2.00 for each additional \$1,000 of costs after that. Building Permits are good for 6 months. The application form is available on the website under *Forms and Permits* or in the Reedsville Municipal Building lobby. Permits can be obtained at the Clerk-Treasurer office located at 217 Menasha Street.

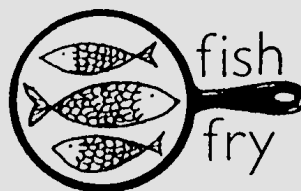

Replacing old lights with new energy efficient LED lights can help you save on your electric bill.

All string lights will be accepted as well as extension cords. Garland, wreaths, trees and other lighted decorations will not be accepted. Normal light bulbs, including spot lights, compact fluorescents, fluorescent tubes, and incandescent bulbs can be recycled but normal fees apply.

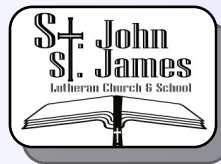

The monthly meeting of the Reedsville Village Board was called to order on October 11, 2018, at 6:30 PM by Village President Jesse Walt.
