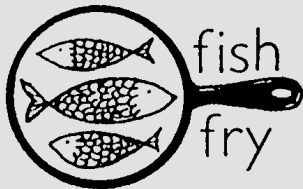

# From the Village Hall

**To all Customers of the Village of Reedsville Sewer Utility.** On December 13, 2018, the Village Board of the Village of Reedsville increased the sewer fixed rate charge from \$15.00 to \$15.45 and the sewer volume charge from \$11.03 to \$11.36 per month effective January 20, 2019. This 3% increase will include all Residential, Commercial, Industrial, and Public Authority customers in the Village of Reedsville.

This 3% increase is necessary to offset increases in operating expenses and to continue to provide adequate service with a reasonable rate of return on the utility's rate base. This rate of return is necessary to maintain the current level of service.

Last sewer fixed charge increase was on December 20, 2011. Last sewer volume charge increase was on May 20, 2015.

**Littering Streets prohibited:** No person shall place, throw, deposit, dump, scatter, leave, **snow, or ice** upon the street, gutter, sidewalk, alley or public ground in the village. Each owner or occupant of any building, dwelling house, store, shop, tenement or structure of any kind and description fronting or abutting on any street, sidewalk, gutter, alley or public ground shall clean the same by sweeping, scraping or shoveling from the sidewalk by or before twelve o'clock (12:00) noon of each day, and shall cooperate with the Public Works Department in keeping the streets, alleys, gutters and public grounds in a clean, tidy and orderly manner.

Check it out.

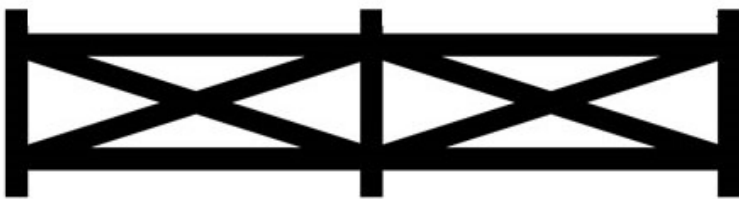

**Proceedings of the Reedsville Village Board**  
**November 8, 2018**

The monthly meeting of the Reedsville Village Board was called to order on November 8, 2018, at 6:30 PM by Village President Jesse Walt. Present were: Joe Cummings, Jerry Reis, Chad Rataichek, Patty Schreiber (arrived at 6:37 pm) and Jack Siebert: Also, present were: Brad and Becky Busse, Stacey Barth, Leroy Krepline, Justin Meyer, Craig Schuh, John Schuh, Sonja Collins, Rick Krahn, Devin Schneider, Atty Mitch Olson, Atty Kate Reynolds, Eric Wisnicky and Dave Nordby.

A motion was made by Reis and seconded by Siebert to approve the agenda as presented. Motion carried 4-0.

Public Input: none

A motion was made by Cummings and seconded by Reis to approve the minutes of the October 10, 2018 meeting as presented. Motion carried 4-0

A motion was made by Reis and seconded by Siebert to pay the accounts payable in the amount of \$231,992.87. Motion carried 4-0.

Correspondence was presented from Valders Ambulance/Rescue Service (October Monthly Report and Notice of Termination and Replacement) and from the ISO regarding the Public Protection Classification Survey. A motion was made by Reis and seconded by Schreiber to approve the Eastshore Humane Assn Agreement as presented. Motion carried 5-0.

The First Responders monthly written report was presented by Barth. Following a discussion regarding the Valders Ambulance Service/Rescue Contract a decision was postponed until the next regular scheduled Village Board meeting.

The Police Dept. monthly written report was presented by Mignon.

The Utility Departments monthly written report was presented by Meyer. C Schuh gave an update on the AT&T proposal. Discussion on utility rates was postponed until the public hearing scheduled for November 28, 2018. Krahn explained that the utility customers will continue to be contacted as they are now.

The Fire Dept. monthly written report was presented by Busse.

The Public Works Dept monthly written report was presented by J Schuh. Following a discussion, a motion was made by Rataichek and seconded by Cummings to purchase a 2002 JD 544H Loader with wing and plow from Brooks Tractor Inc.in

the amount of \$82,675 pending visual approval from J Schuh and Krepline. Motion carried 5-0. A decision on providing snow plowing services to the Reedsville Housing Authority was postponed until the next regular scheduled Village Board meeting.

A meeting with the USDA will be scheduled for December 5, 2018 at 4:00 pm pending approval with the USDA rep. Ayres Assoc. will prepare a contract for the LRIP 5<sup>th</sup> Street project. A meeting to work on the 2019 budget was scheduled for November 12, 2018 at 5:00 pm. Upon reviewing the proposals, a motion was made by Reis and seconded by Cummings to approve the proposal from Collins State Bank for the 4<sup>th</sup> Street Bridge Project loan in the amount of \$149,000. for three year at a fixed interest rate of 3.99%. Motion carried 5-0.

The discussion on the RAA/Reedsville Fire Dept. fields was postponed until all parties involved can meet.

The next regular monthly meeting will be held on Thursday, December 13, 2018 at 6:30 PM. A motion was made by Reis and seconded by Siebert to adjourn the meeting. Motion carried 5-0. Meeting adjourned at 8:00 PM.
