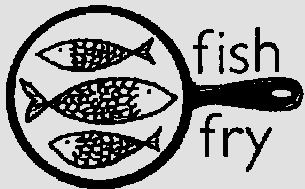

# From the Village Hall

**Cat & Dog Licenses** are due on or before April 1st. Unspayed females and unneutered males are \$10.00 each. Spayed females and neutered males are \$5.00 each. You must show proof of a valid rabies shot. **Failure to obtain a license by April 1st, will result in a late fee of \$20.00 per pet.**

**Solid Waste & Recycling Carts** need to be out on the curb by 5:00 am for service. DO NOT place carts within 4' of any objects such as utility poles, mailboxes, or vehicles. Carts need to be on separate sides of your driveway or at least 4' apart. Carts placed on the street or on snow banks will not be serviced.

**Water Softeners:** Any water softener installed must be rated to have a salt efficiency of at least 4000 grains of hardness removed per pound of salt used, must be approved and inspected by a representative of the Village of Reedsville and must regenerate on demand only.

**Parking Tickets and Reedsville News Advertising Fees:** You can use your credit/debit card to pay these charges. The Village of Reedsville has partnered with *Point & Pay* for this service. #### Proceedings of the Reedsville Village Board December 13, 2018

The monthly meeting of the Reedsville Village Board was called to order on December 13, 2018, at 5:00 PM by Village President Jesse Walt. Present were: Joe Cummings, Jerry Reis, Chad Rataichek, Patty Schreiber and Jack Siebert. Also, present were: Brad Busse, Michelle Foytik, Leroy Krepline, Justin Meyer, Craig Schuh, John Schuh, Joe Tisler, Atty Richard Mozinski, Sonja Collins, Andrew Flowers, Corey Hoppenrath, Becky Busse, Gene Bauknecht, Chris Dallas, Stacey Barth, Cindy Carter and Dave Nordby.

A motion was made by Cummings and seconded by Siebert to approve the agenda as presented. Motion carried 5-0.

At 5:30 pm a motion was made by Reis and seconded by Siebert to convene into closed session pursuant to Section 19:85(1)(g) to confer with legal counsel on the proposal from AT&T. Motion carried 5-0. At 6:00 pm a motion was made by Reis and seconded by Siebert to reconvene into open session. Motion carried 5-0.

Meeting resumed at 6:30 pm

Public Input: Bauknecht expressed his concerns on being told he could hook his sump pump into the storm sewer.

A motion was made by Schreiber and seconded by Cummings to approve the minutes of the, November 8, 2018 meeting as presented. Motion carried 5-0

A motion was made by Schreiber and seconded by Siebert to pay the accounts payable in the amount of \$216,066.30. Motion carried 5-0.

Correspondence was presented regarding the Valder's Ambulance Service for November 2018. A motion was made by Siebert and seconded by Cummings to approve the Operator License Applications from Tiffany Regazzi, Theodore Sterleske, and Kalie Ingalls. Motion carried 4-0 (Schreiber abstained). A motion was made by Siebert and seconded by Cummings to approve the Agreement for Special Law Enforcement Services from the City of Brillion in the amount of \$28,820.00. Motion carried 5-0.

The First Responders monthly written report was presented by Foytik. Walt turned the meeting over to Reis to discuss the Valder's Ambulance Service/Rescue Contract. A motion was made by Reis and seconded by Schreiber to sign the Contract as presented. Motion carried 5-0. Reis turned the meeting back to Walt. Note: Contract was signed by Reis.

The Police Dept. monthly written report was presented by Tisler.

The Utility Departments monthly written report was presented by Meyer. A motion was made by Siebert and seconded by Reis to authorize Atty Mozinski to contact the Village Attorney to see what the procedure will be for the height variance request, to move forward on the construc-

tion of the monopoly by having the variance public hearing, to finalize the lease to include insurance coverage and to be reimbursed for legal and postponement fees. Motion carried 5-0. Following a discussion, a motion was made by Reis and seconded by Schreiber to increase the sewer fixed and volume charge by 3% effective January 20, 2019. Motion carried 5-0. The discussion on the PTO Options was postponed until the next regular scheduled Village Board meeting. A motion was made by Schreiber and seconded by Cummings to have Speedy Clean do CIPP repairs in the amount of \$15,430.00. Motion carried 5-0. A motion was made by Siebert and seconded by Schreiber to have Crane Engineering do repairs on the submersible pump in the amount of \$5,950.00. Motion carried 5-0. A motion was made by Cummings and seconded by Siebert to have Crane Engineering install the tea cup valve in the amount of \$2,985.00. Motion carried 5-0. A motion was made by Siebert and seconded by Cummings to contact Donald Heiptas & Sons to find and repair the leak on Elm Street. Motion carried 5-0. A motion was made by Reis and seconded by Siebert to approve Amendment 1 to the Scope of Services Agreement from Ayres Associates for the Water Tower Painting Project in the amount of \$12,000.00. Motion carried 5-0.

The Fire Dept. monthly written report was presented by Busse. A motion was made by Cummings and seconded by Reis to approve the resignation from Alex Klimesh from the Fire Department. Motion carried 5-0.

The Public Works Dept monthly written report was presented by J Schuh. Rataichek will obtain pricing for a Chevy pickup truck. The discussion on the snow plowing services for RHA was postponed until the next regular scheduled Village Board meeting. Following a discussion, it was thought that one USDA project will be bid out in fall of 2019 with completion in 2020 and the rest would be bid out in fall of 2020 and constructed in 2021. C Schuh recommends we televise private laterals as part of the projects. Prices will be obtained for this. A motion was made by Reis and seconded by Cummings to approve the Proposal from Ayres Associates for the Engineering Services for the 5th Street LRIP project in a lump sum amount of \$8,500.00. Motion carried 5-0.

The discussion on the RAA/RFD fields was postponed until the next regular scheduled Village Board meeting.

The next regular monthly meeting will be held on Thursday, January 10, 2019, at 6:30 PM. A motion was made by Reis and seconded by Siebert to adjourn the meeting. Motion carried 5-0. Meeting adjourned at 8:40 PM.
