From Village Hall

Garbage, Rubbish and Recyclables From Outside of Municipality: It shall be unlawful for any persons to place, deposit or cause to be deposited for collection, any garbage, rubbish or recyclable materials from outside the boundary limits of Reedsville into the Village unless authorized by an agreement with the Village.

Improper Use of Garbage, Rubbish or Recycling Receptacles: It shall be unlawful for any persons to place, deposit or cause to be deposited in or on any receptacle, or compost area not belonging to or assigned by the owner without the permission of the owner or designated assignee unless such receptacle or areas is designed expressly or implicitly for use by the general public.

Compost: Yard waste such as grass clippings, leaves, and yard & garden waste shall be disposed of by composting the material or leaving it at the Village compost site. Items NOT to be put in the compost are: stumps, roots, shrubs with intact root balls, animal waste, pine cones and sod.

Defecation on Private or Public Property: It shall be unlawful for any person owning or in control of a dog or cat to allow or permit such animal to defecate on any private or public property owned by another person. Violation of this shall be punishable by a forfeiture of anywhere from \$20.00 to \$200.00

Trick or Treat Hours: The Village of Reedsville will hold Trick or Treat on Sunday, October 27th from 2:00 PM to 4:00 PM.

Chipping Dates: October 1st & 15th October 15th will be the last date until April 2020.

Recycling Pick-Up: October 4th and 18th

Reedsville Alumnus to Hike 28.1 Miles in One Day to Tell Children's Cancer to TAKE A HIKE.

On Saturday, October 5, Melanie Kulas, alumnus of Reedsville High School, will trek more miles before 8 AM than most people will walk all day. The monthly meeting of the Reedsville Village Board was called to order on August 8, 2019, at 6:30 PM by Village President Jesse Walt. Present were: Becky Busse, Terry Hansen, Jennifer Maertz, Chad Rataichek, Patty Schreiber and Jack Siebert: Absent. Also present were: Brad Busse, Michelle Foytik, Leroy Krepline, Justin Meyer, Craig Schuh, Rick Krahn and Cindy Carter.

A motion was made by Be Busse and seconded by Rataichek to approve the agenda as presented. Motion carried 6-0.

At 6:35 pm a motion was made by Siebert and seconded by Schreiber to convene into closed session pursuant to Section 19:85(1)(g) to confer with legal counsel on the proposal from AT&T. Motion carried 6-0. At 6:43 pm a motion was made by Siebert and seconded by Schreiber to reconvene into open session. Motion carried 6-0.

A motion was made by Siebert and seconded by Schreiber to amend the agenda to include Resolution 2019-8. Motion carried 6-0. Resolution 2019-8 authorizing the Village President to sign the First Amendment to the Memorandum of Lease and the Seconded Amendment to the Tower Site Lease Agreement with AT&T was introduced by Siebert. A motion was made by Schreiber and seconded by Rataichek to approve the Resolution as presented. Motion carried 6-0.

A motion was made by Schreiber and seconded by Maertz to approve the minutes of the July 11, 2019 meeting. Motion carried 6-0

A motion was made by Schreiber and seconded by Maertz to pay the accounts payable in the amount of \$156,957.34. Motion carried 6-0.

The monthly report was presented from Valdars Ambulance Service. A motion was made by Be Busse and seconded by Hansen to approve the Operator License Applications from Savannah Schanilec and Teri Horn. Motion carried 5-0 (Schreiber abstained). Correspondence was presented from Brett Yohanek (Meadowbrook MHP) regarding a need to have a designated area for cases of severe weather. Following a discussion, a motion was made by Rataichek and seconded by Schreiber to send a letter explaining that the Municipal Building will be available but they need to understand that the Fire Dept may not be available to open right away and that they should have an alternate location. Motion carried 6-0.

The Police Dept. monthly written report was presented by Mignon.

The Fire Dept. monthly written report was presented by Busse.

The Utility Departments monthly written report was presented by Meyer. Following a discussion, it was decided to have a special meeting on August 15, 2019 at 5:30 pm to discuss the USDA project. A motion was made by Siebert and seconded by Hansen to approve the

First Amendment to Memorandum of Lease with AT&T. Motion carried 6-0. A motion was made by Be Busse and seconded by Maertz to approve the Second Amendment to the Tower Site Lease Agreement with AT&T. Motion carried 6-0.

The Public Works Dept monthly written report was presented by Krepline. A motion was made by Be Busse and seconded by Maertz to order a new wireless scoreboard for Bubolz Memorial Park from Varsity Scoreboards. Motion carried 6-0. Krepline explained the Menasha Street project is complete and they are still obtaining quotes for the Park Street lights. Sump pump run offs will be taken care of on an individual basis.

The First Responders monthly verbal report was presented by Foytik.

Krahn explained the need for Board Members to attend the Village Assn meetings where the NIMS training will be presented and that Reedsville will be the next Municipality to run the Association meetings. Krahn asked the Departments to have their proposed budgets to her by the end of August so the Board can start working on the General Budget in September.

Walt talked to Pautz about cutting the Reedsville Athletic Assn field and to submit a bill for his time.
