Manitowoc County Compost Site Ashes

This is a reminder to people using the compost sites in Manitowoc County that ashes are not accepted. Ashes should never be dumped at the compost site for two important reasons. First, even if ashes seem cool they often still contain embers that can reignite and start fires. This is especially true in windy, dry conditions when they are piled amongst dry leaves. Unfortunately, Recycling Center staff have had to extinguish multiple fires from patrons carelessly dumping ashes at the site in previous years. The second reason ashes are not accepted is they may contain undesirable chemicals from whatever was burned and we have no way to know if they came from clean wood, treated lumber, household trash, or worse. We do not want these contaminants in our finished compost products.

The best thing to do with your ashes is to use them at your property or thoroughly douse them in water and let them sit at least a month before taking them to the landfill. If you use a solid waste hauler or municipal drop off site be sure to check their guidelines too; many places do not accept ashes for fire safety reasons.

Throwing ashes in the compost pile, or anywhere else on the site, is considered illegal dumping and is a violation of Manitowoc County Code 6.12 and may be subject to fine. Please follow the guidelines we have when using the compost sites and the recycling depot. We have these guidelines in place to keep our programs running safely and efficiently. If you have materials you are unsure of then stop in the office to ask, call 920-683-4333, or visit us online at Manitowoccounty.com/recyclingcenter.

Cat & Dog Licenses: Unspayed females and unneutered males are \$10.00 each. Spayed females and neutered males are \$5.00 each. You must show proof of a valid rabies shot. Please make out a separate check for the licenses as it goes into a different account.

Holiday Tree Drop-off: Manitowoc County residents and business may drop off their natural holiday trees at the Basswood Compost Site from 7:00 am to 4:00 pm, Monday through Friday, and Saturdays from 8:00 am until noon. Please remove all ornaments, tinsel, lights, stands and storage bags before dropping off. If the tree is more than 6 feet long, it must be cut in half. The Basswood compost is located at 3000 Basswood Rd., near the intersection of County Road P and R. Call 683-4333 or visit www.manitowocrecycles.org for additional information. The Village does not pick up or chip Christmas Trees

The Utility Dept. monthly written report was presented by Meyer. The DNR will be contacted regarding when the dead-end hydrants must be installed by.

The Public Works Dept. monthly written report was presented by J Schuh. C Schuh gave an update on the USDA project/bidding status. The discussion on chipping has been postponed until March 2020. Following a discussion, a motion was made by Siebert and seconded by Schreiber to have the trees trimmed in the Firemen's Park and the cost will be shared with the Fire Fighters. Motion carried 5-0.
