## 2020 CENSUS: WHAT YOU NEED TO KNOW

### HOW TO VERIFY A MAILING IS FROM THE CENSUS BUREAU

If you receive a survey or a letter in the mail from the Census Bureau, the envelope contains information that will help you verify its legitimacy.

For example:

-“U.S. Census Bureau” in the return address or “U.S. Department of Commerce” which is the Census Bureau’s parent agency.

-Jeffersonville, IN in the return address. The Census Bureau has a mail processing center located there.

## WHY WE CONDUCT THIS COUNT

The census provides critical data that lawmakers, business owners, teachers, and many others use to provide daily services, products, and support for you and your community. Every year, billions of dollars in federal funding go to hospitals, fire departments, schools, roads, and other resources based on census data.

The results of the census also determine the number of seats each state will have in the U.S. House of Representatives, and they are used to draw congressional and state legislative districts.

It's also in the Constitution: Article 1, Section 2, mandates that the country conduct a count of its population once every 10 years. The 2020 Census will mark the 24th time that the country has counted its population since 1790.

## IMPORTANT DATES

**MARCH 12 - 20:** Households will begin receiving official Census Bureau mail with detailed information on how to respond to the 2020 Census online, by phone, or by mail.

**MARCH 30 - APRIL 1:** The Census Bureau will [count people who are experiencing homelessness](#) over these three days. As part of this process, the Census Bureau counts people in shelters, at soup kitchens and mobile food vans, on the streets, and at non-sheltered, outdoor locations such as tent encampments.

**APRIL 1 :** Census Day is observed nationwide. By this date, every home will receive an invitation to participate in the 2020 Census. Once the invitation arrives, you should respond for your home in one of three ways: online, by phone, or by mail. When you respond to the census, you'll tell the Census Bureau where you live as of April 1, 2020.

## WHY IT'S REQUIRED

Getting a complete and accurate census count is critically important. That's why your response is required by law. If you do not respond, the U.S. Census Bureau will follow up in person to collect your response.

Why is the census so important? The results are used to determine how much funding local communities receive for key public services and how many seats each state gets in Congress. State and local officials also use census counts to draw boundaries for congressional, state legislative, and school districts.

And while you are required by law to participate, the Census Bureau is also required by law to protect your answers. Your responses are used only to produce statistics. The Census Bureau does not disclose any personal information.

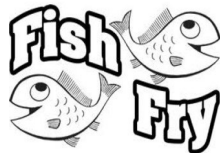
### SUNRISE HORSE FARM

In January while on a mission trip to Honduras, Belize, and Cozumel a school in Belize asked us to talk to the students about the culture in the United States. Some from our group talked about farming, the weather in Wisconsin and in other states, they helped them make paper snowmen and snowflakes and of course my subject was Sunrise Horse Farm. In talking to them about Smokey and Spencer (he is blind) I was able to relate to them the importance of coming alongside another person that is in need and being their friend. If you have not heard the story before, you can hear it now. In 2017 we had difficulty getting committed volunteers so we were faced with the choice of downsizing from five horses and a pony to two horses. So in late October the last two horses were trailered out and Smokey was not happy. He ran in back of the barn snorting, kicking and his eyes were blazing so I gave him permission to run it off and went about my day. Because Spencer was in his stall and he needed to get out I went back to the barn three hours later. With the halter on Spencer I was leading him through the barn and there came Smokey. Now remember Smokey and Spencer had never been together because they were on separate ends of the barn so this was their first meeting. When horses come together they communicate with their noses touching each other and they will determine if they are friends. If not, there will be trouble and possibly a fight! So there we were and Smokey came in, his eyes still big, however, the snorting and kicking had stopped. He approached Spencer, noses touching and took a step back...and then came forward and pressed his face tight against Spencer's...they were friends. And that was the beginning of Smokey teaching Spencer how to get in and out of the barn, how to find the water tank, how to cross the water hole to get to the pasture, and to run as if he can see. The students were very attentive, asked questions and one boy wanted me to bring a horse back to Belize!! This lesson is not only for students, we adults also know people that are in need of a friend. Check your schedule as there will be more training in March for anyone interested in volunteering. Bring your talents to be a friend to someone.

### NOTES FROM THE VILLAGE HALL

**Cat & Dog Licenses** are due on or before April 1st. Unspayed females and unneutered males are \$10.00 each. Spayed females and neutered males are \$5.00 each. You must show proof of a valid rabies shot. **Failure to obtain a license by April 1st, will result in a late fee of \$20.00 per pet.**

**Solid Waste & Recycling Carts** need to be out on the curb by 5:00 am for service. DO NOT place carts within 4' of any objects such as utility poles, mailboxes, or vehicles. Carts need to be on separate sides of your driveway or at least 4' apart. Carts placed on the street or on snow banks will not be serviced.

**Water Softeners:** Any water softener installed must be rated to have a salt efficiency of at least 4000 grains of hardness removed per pound of salt used, must be approved and inspected by a representative of the Village of Reedsville and must regenerate on demand only.

**Clerk/Treasurer's Office Hours:** Monday, Tuesday, Thursday, & Friday 8:30 am to 4:30 pm CLOSED WEDNESDAY. Office is located at the Reedsville Municipal Building, 217 Menasha Street.

ELDERBERRY D3FENSE-Elderberry D3fense provides important nutrients for optimal immune system function, particularly during the change of seasons--a time when both the immune and respiratory systems are often challenged. A prospective cohort study revealed that healthy individuals with higher concentrations of vitamin D demonstrated a significant two-fold reduction in the risk to developing acute respiratory tract infections, compared to those with lower levels of vitamin D. ELDERBERRY is primarily used as an antiviral agent to improve immunity against colds and influenza. Research suggests that taking elderberry at the first sign of a cold or flu may cut recovery time in half. For example, a randomized, double-blind placebo-controlled study of patients with influenza A and B infections found that elderberry relieved flu-like symptoms an average of 4 days earlier compared to placebo. In addition, a recent study found that elderberry inhibited human influenza A (H1N1) infection in vitro--the inhibitory action was likened to the anti-influenza activities of the antiviral drugs Tamiflu and amantadine. ECHINACEA is notably the most recognized herbal supplement for preventing and treating colds and flu. Echinacea demonstrates antibacterial, antiviral and immunomodulating properties. For example, a meta-analysis of 14 studies found that echinacea reduced in incidence of the common cold by 58%. WILLOW BARK. Derivatives of willow bark have been used since ancient times to treat a variety of aches, pains and fevers. Clinical trials have confirmed the effectiveness of willow bark for short-term relief of pain due to the active ingredients, namely salicin and salicylate-like compounds which is considered chemically similar to aspirin. ROYAL JELLY is a nutrient-rich substance that is secreted from the glands of worker bees and fed to the queen bee. Clinical trials have shown that royal jelly's antimicrobial activity is approximately 75% as effective as penicillin, an antibiotic drug used for upper respiratory tract infections. OLIVE LEAF contains active ingredients that have been shown to be powerful in vitro inhibitors of numerous viruses, including cold and influenza viruses.
